Cranberry Marsh total construction cost is \$952,971. The Federal \$762,377 our share \$190,594.

According to Monarch, fine grading maybe this week, paving next week as of now for Larrabee subdivision and viola lake and Culbertson.

Community Bank was called and the prime interest rate increased to 4.5%. He agreed to match what the state interest rate is.

\$244,000 is needed to be financed to black top Viola Lake, Larrabee Subdivision, and Culbertson. With one payment due each year in August. Scott makes the motion to go to community bank with the rate of 4.5% for approx. 1.7 miles of road with a two year pay back and the first payment to be due next August 2023. Mike seconded the motion.
