BM mentioned the fired alarm and how it disturbed her and CHN's sleep and was "traumatic" because of how startled she and CHN were. BM also mentioned that because of the fire alarm, CHN were home from school. BM asked if CP could speak to the workers at the shelter about when the fire alarms go off and to talk to the school so that CHN's absence would be excused. CP said that this would ot count as an excused absence and that the shelter has their own policies that CP wouldnt be able to change. CP encourage BM to get CHN to school even on mornings when it's hard to.

CP asked BM if SC Joe still had an upcoming appointment with BrightPoint. BM said yes and that his appointment is set for Friday, November 8<sup>th</sup>. CP asked if BM also made an appointment for herself. BM said that she did and that it was set for the first week of November, though she didn't remember what day exactly. CP encouraged BM to go to the appointment and take SC Joe to his appointment because it would further assist CP in what services to align BM and family with. BM said that she understood and shared that she didn't see the point in going to BrightPoint and getting settled with a therapist, only to leave and do it all again at another facility when the family moves out of the shelter if that works out. CP said that she understood her concern and said that though it's tiring, it will lead to a greater outcome for her and her family than not going and waiting until later to receive services.

CP then transitioned into completing the developmental milestones form with BM for SC Joe. BM disclosed that SC Joe was healthy and that she had a normal pregnancy. BM also disclosed that during her pregnancy, one of the tests showed that she had drugs in her system. BM said that it may have been through something BF of SC Joe gave her to eat but that she doesn't know how it got in her system. BM also said that SC Joe had an allergic reaction to amoxicillin to which he develops a rash on his skin. BM disclosed that when SC Joe was a baby, he had an allergic reaction and other people thought that she was abusing him. BM believes this was a reason as to why he was taken away from her when he was younger.

During the visit, SC Margaret attempted to adjust a fan because she was hot but the fan fell. No one was injured and the knob of the fan broke off. SC Joe fixed the knob while SC Margaret ran to BM to be comforted because she was startled. BM reprimanded SC Margaret by raising her voice and telling her that she needs to ask for help instead of doing things on her own. CP said that she was glad that everyone was okay and that SC Joe was able to fix the knob. BM said that SC Margaret often tries to do things on her own and that she doesn't listen to her. BM mentioned that other workers have also spoken about SC Margaret's actions. CP asked BM what discipline looks like for CHN. BM said that she's not good with disciplining SC Margaret because she doesn't listen. BM also said that she would put her in time out for a couple of minutes and remove her toys as a means of discipline. CP said that doing those things showed good parenting skills. CP asked BM about the parenting class she took and if the skills she learned there were helpful. BM said at the class wasn't helpful, saying that they only focused on the childhood experiences of the parents and not practical skills for Lisciplining children. CP said that she will look into parenting classes for BM.

#### Interview- School Personnel

Ms. Delgado explained that SC Margaret is always exhausted when she comes to school. She said the SC would complain saying that she's tired, Ms. Delgado also disclosed that she saw BM and SC on the bus one evening during the week at around 8pm on their way to McDonald's, Ms. Delgado said that she didn't say anything to BM on the bus because it was not the right setting, but believes that SC should've been getting ready for bed at that time.

Ms. Delgado also disclosed that SC has been sick for longer than usual, she explained that SC has been congested for about a month. Ms. Delgado reports that SC comes to school clean and neat and that there are no hygienic concerns.

Ms. Delgado reports that SC's teachers and other workers said that it is hard to keep SC on topic in class and in their sessions. They report that SC would frequently talk about the past trauma her and her family experienced. Ms. Delgado said that she is coaching the other workers on how to handle those moments, explaining that it is good that SC is able to talk about these things, but it isn't the right time for these conversations. Ms. Delgado disclosed that SC would say things that she may have witnessed and other things that she heard BM say and is repeating it. Ms. Delgado shared that she would say things like "daddy kicked mom in the stomach", "we moved from a hotel and now we live in a shelter", and "mommy doesn't like when I see daddy". Ms. Delgado said that it's evident that BM talking about the trauma has an impact on SC and that BM needs another outlet to do so where SC won't hear.

Ms. Delgado also reports that the school has been having trouble getting BM to sign and return forms. She explained that they would send form home and won't get them back.

In regards to SC's development, Ms. Delgado shared that she has trouble imitating actions like clapping. Ms. Delgado explained that she didn't think that SC belonged in a D75 school but that as she works with her, she is starting to see where the gaps are in SC's development, Ms. Delgado suggests that BM should read to SC and have SC read to her.

Ms. Delgado also disclosed that SC acts appropriately with other children and that she isn't scared or startled by loud noises. She also shared that SC would make appropriate comments and greetings like telling another worker "have a good lunch" when she left the room.

## Interview-Subject Child

SC Margaret spent a few minutes with us, explaining that she has to go on the school bus. SC was alert and social. SC played with a few of the toys Ms. Delgado had while she spoke to the workers. SC shared how she hoped BM made soup for lunch and shared that her favorite meal is spaghetti. SC was free of any visible marks or bruises and was not in any distress or discomfort.

He informed Minnie that they were going to watch a movie, however Minnie wanted to go to the play area and "make friends" after she finished eating. BF informed SC that she was there to spend time with her and wanted her to stay there. He repeatedly reminded child about "the old times" stating they use to watch movies all the time.

Child repeatedly said she was bored and wanted to go to the front to play and make friends

CPS observed that BF has BM and SC picture on his laptop as a screen saver. CPS observed BF to have at least 5 DVD movies, however he chose to play a home video he made with the family in the park when Minnie was 2 years old. The video kept Minnie focused for a while. Child frequently asked BF to lift her up so she could see over the cubicle into the play area. BF did this three times, the last time Minnie became angry and had a temper tantrum after BF said he was not going to allow her to go into the playroom. CPS observed child grab BF shirt pull it, kick him hit home and yell at him asking to please lets go. BF was observed to become flustered and appeared to become anxious. CPS observed BF to close his eyes and asked Minnie to clam down. Child fell asleep after crying and BF just rubbed her hair and her knees.

.P asked BM why CHN were not in school. BM said that while they were getting ready to leave the shelter, SC Minnie was having a tantrum. BM explained that SC Minnie was screaming and spitting on the elevator and then when SC Joe tried to calm her down, she punched him in the stomach. BM said that she couldn't get SC Minnie to the bus stop or to school because of her actions and that SC Joe didn't go to school because his stomach was hurting. BM also mentioned that SC Minnie often gets physically aggressive with SC Joe.

CP asked what SC Joe and SC Minnie's interactions look like and if BM ever leaves them alone. BM said that SC Joe is helpful in caring for SC Minnie and that they would play together, BM said that she would only leave them together for a short amount of time in public places. CP suggested that BM keep a close eye on how they play because if SC Minnie is being aggressive with SC Joe, she's uncomfortable. During this conversation, SC Joe and SC Minnie were playing and SC Minnie said "stop Joe" and then hit him. SC Joe complained that SC Minnie hit him. CP told SC Joe that if SC Minnie says to stop doing something, that he should stop. CP also told SC Minnie that it is not nice to hit her brother and encouraged her to apologize to him. CP also redirected how SC Joe handled SC Minnie, telling him to put her down gently if she's getting fussy about how he's holding her.

CP asked what discipline looks like for SC Minnie and SC Joe. BM stated that she would say no to things but when the CHN start complaining or when SC Minnie starts acting out, she would give in so that they can be happy. CP said that sometimes you have to say no, and when you say no to stick to that no. BM said that she tries to but she doesn't want her CHN to look sad because then she believes it would give reason for ACS to believe the reports that BF has been making and call her a bad mother or even take her CHN away. CP encourage BM that she is a great mother and that she has and continues to do what she can for CHN. CP also said that its not expected that CHN always look happy and that discipline is also a sign that she loves and cares for them. BM said alright and that she's a bit on edge because of all the SCR reports that have been made against her.

CP asked for a follow up on SC Minnie's vaginal discomfort. BM said that she went to the doctor who diagnosed her with a UTI. BM said that she's giving SC Minnie antibiotics as prescribed by the doctor for her UTI. BM said that she's not sure why SC Minnie is having this problem and said that maybe she's wiping wrong. CP encouraged BM to reiterate to SC Minnie the proper way to wipe and to supervise her to ensure that she's doing it correctly. BM agreed.

CP asked BM what their sleep routine looks like. BM shared that the CHN go to sleep at around 10 or 11 pm. BM explained that after visits with BF, she would have to either make dinner or buy fast food to save time and then doing homework and taking a bath before bed takes a lot of time. CP suggested that BM cook in bulk and warm up a few plate in the oven when they get home from visits. CP also suggested having a wind down routine for the CHN so that they are ready for bed. CP mentioned that BM should refrain from having screen time late at night and play soothing sounds to help put he CHN asleep and keep them asleep through the night. CP said that if the CHN are sleeping better, they would be more energized when getting ready for school and that they would be more energized while in school.

that BM shared that SC Minnie is aggressive at home and asked if she has the same behavior at school. Ms Delgado shared that SC Minnie is very pleasant when playing with other students and in her interactions with adults. Ms Delgado also shared that she believes that parenting classes for BM would be helpful. Ms Delgado shared that during their Parent Teacher Conference, she emphasized the need to discipline SC Minnie. Ms Delgado also noticed that SC Joe was very active in caring or SC Minnie but mentioned that it's to the point where he becomes another parent figure. Ms Delgado shared that she would give BM some tips such as sticking to a no when disciplining SC Minnie instead of saying no and then giving in and giving SC Minnie what she wants. Ms Delgado said that though she and other teachers were giving BM helpful tips, it wasn't the right environment and that she can tell that BM was feeling overwhelmed. CP said that BM is set to start a parenting training module soon that will address her interactions with her CHN.

Ms Delgado also mentioned that there are some issues with sleep because SC Minnie would often times complain about being tired at school and would be yawning or falling asleep. CP shared with Ms Delgado that she spoke to BM about forming a set sleep routine and will follow up with her about how that's developing.

CP asked Ms Delgado about how SC Minnie is doing with talking about her trauma. Ms Delgado said that she's better with talking about the trauma, explaining that SC Minnie wouldn't blurt it out in class like she did before.
