He brought kinetic sand, bubble machines, games, a portable DVD player, a book, cars, etc. During one visit, the child stated that "Mommy and Joe is going to be so happy," when she brought the toys home, and Mr. Malek said, "I'm so happy that mommy is happy." During another visit, Mr. Malek brought a large air hockey table to the visit and spent half the visit putting it together and the other half playing with young Margaret. This writer had to talk with the father about not bringing such large items to the visits as they were too big for the space provided and the packaging created too much of a mess. Mr. Malek agreed, and stated that he would take into consideration the size of the office when picking out gifts and would put the toys together before coming to the office for the sake of time and cleanliness. Also, the father not to use toys intended for outside play indoors for the same reasons, one example is the very large bubble machine he brought to the February 18, 2019 visit. Mr. Malek was very affectionate with his daughter, giving her hugs, kisses, stroking her back, telling her how pretty she is, and saying how much he loved her. The father also provided praise to his daughter with such phrases as "very good Minnie" and "I like how you do that." He encouraged her to do her best and to not give up because a task may be too hard. As evidenced in her affection, communication, and body language the child appears very comfortable around her father. She listened to him and followed his directions when he tried to assure she was safe and did not hurt herself. Mr. Malek tried to create a very entertaining environment for his daughter during visits with all the toys and collaborative play with her. They laughed and smiled together during play. On February 28, 2019 visit, the father brought a book to read to his daughter. Young Margaret will be starting school in the fall of 2019, so it seemingly would benefit the child to try and make some of the visit time focused on education or reading. This writer spoke with the father about purchasing educational videos and books for his daughter in the future. They discussed trips they have been on such as going to the beach together. During the January 22, 2019 visit Margaret reported that she was playing with Joe, her half-brother, and he "threw [her] on the bed," and she hurt her tongue. The father told his daughter that he was "sorry to hear that and [he] and [the writer] would talk about it." The father asked the child about any scratches, small bruises, or rashes she had, asking her how or why they happened. Margaret mainly told her father they were from playing, yet on the February 28, 2019 visit she did not explain a small scratch on her cheek, which concerned Mr. Malek. At times, the child was defiant and did not listen to her father when he tried to prevent her

from taking her stockings off or not to pour the bubble solution into the machine. The father seemed to have difficulty in setting limits and boundaries for his daughter as noted in him always giving in to what she wanted despite the need to do otherwise. When Margaret cried and screamed as he tried to keep her stockings on, the father had difficulty getting Margaret to comply. When asked by this writer to keep Margaret dressed, he stated, "the same thing happened at ACS, and I come out looking like the bad guy." Most visits ended late because the father did not have his daughter ready to leave or had not cleaned up the visit room prior to the appointed time.

It should be noted that throughout the past few weeks Mr. Malek has contacted this writer by repeated phone calls, texts, and emails. In these communications, Mr. Malek has complained about numerous minor details (the size of the visit room or giving soap to his daughter) and CFS policy/procedure. He stated that this writer failed to follow up on the ^{NOT TRUE} statement that Joe "threw Margaret on the bed," despite the undersigned telling the father that it was discussed with the mother. Also, Mr. Malek continued to express his belief that CFS should schedule additional time for him to allow for his visit to be extended in the event that the mother is to arrive late again, even offering to pay for the time. This writer informed Mr. Malek that it was the expectation that both parties would arrive on time and that any delays would be relayed to the Court, and that CFS could not schedule additional time based on his predictions regarding the mother's behavior. As stated earlier, Mr. Malek cancelled a visit, claiming this writer was "a liar," "evil," and "mean" when extra time could not be allotted for the February 21, 2019 visit. As for the other concerns raised, Mr. Malek was redirected to discuss these with either his attorney, ACS, or the Court

There was ur initial difficulty in even setting up the intake with her that took more than a month for her to show. I experienced this at acs often. Yes please, if you can request documentation for any cancellations or " illness " as to why there are so many issues it would be good. Thank you. I also just want to make note that minnie shows up with a 5 inch doll last time with just a shirt that mommy " found " but her atny asks me to give her no more toys. My atny said me buying for joe as well would be the right thing to do so I am in the process of doing so. Hope to see minnie tomorrow.
