In addition, the temperature was cool within the home at the time of the visit. Interaction was positive throughout the visit

ENGAGEMENT:

The engagement process was smooth

FAMILY ASSESSMENT

Cp said hello to client and her paramour who began by informing Cp of a disagreement between himself and client. Mr. Malek began addressing client's weight stating that she gained a lot of weight since having Minnie. Mr. Malek then continued to disgrace client in Cp's presence regarding her weight. Cp first sent the kids into the bedroom then stopped Mr. Malek and informed him that what he was doing was wrong and tried to justify it by saying the client told him that she wanted to kill him. Client reported that she said that because she was angry and also because her paramour kept nagging her and reported that she just wanted it to stop. Client complained that she was tired arguing and going back and forth with Mr. Malek.

LIBBS IS LYING + COVERDIN FOR Cp then informed client that Cp contacted ICL who needed the Medicald number for client and Joe prior to them making an MANLANCE appointment. Cp also informed client that Cp tried several times to contact client to obtain the Medicaid numbers however client reported that her phone was disconnected as her paramour did not pay the bill. Client provided Cp with the Medicaid numbers for both herself and Joe. In addition, CP also requested the names of the medications Joe was supposed to be taking however client and her paramour both stated that Joe no longer takes his medication and agreed that Joe is doing much better without it. According to client and her paramour. Joe is functioning better daily and is not "zombie like" and does not sleep as much. Op informed clients that they are not at liberty to make that assumption since Joe was recently admitted in the hospital due to intense mental health concerns. Cp informed the family that Joe has to take his medications unless informed otherwise by a doctor. Op stressed the importance and benefits of Joe taking his medication to the family.

Cp was asked by client to walk with her to the bedroom to obtain the name of Joe's medication. Ms. Ingoglia discussed to Cp that she is being degraded and called names by her paramour. In addition, Ms. Ingoglia stated that she is also being controlled by her paramour; client stated that at times when he has to go to work he takes her and their daughter to a nearby park close to his job and when he is finished work he picks them up. Client went on to say her paramour was the reason for her son's nervous breakdown / Furthermore, client stated that recently one day her paramour was so mad at her son he went up to his face yelling and screaming at him. As she was crying client stated that she wants to leave with her son because she is in fear of their lives. Client added that if she takes her daughter her paramour will find them, also client reported that he will terrorize her mother since he is aware of her address. Cp informed client that Cp will help her.

Client provided Cp with the name of the medications; quetiapine fumarate to be taken once daily at bedtime and sertraline to be taken once daily in the morning. CP informed client that Cp wilk contact ICL tomorrow to finalize scheduling the appointment to start the therapy process, client agreed and thanked Cp. Mr. Malek did mentioned that he contacted ICL on several occasions after they left him a message, however Mr. Malek reported that no one called him back.

CULTURAL COMPETENCE

Client believes that she is being abused verbally as she reported to be constantly put down by her paramour. Client reported that she wants to leave but not with her daughter for fear that it may awaken the beast in her paramour.
