AN ORDINANCE CALLING A SPECIAL ELECTION IN THE VILLAGE OF ST. ELIZABETH, MISSOURI, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF SAID VILLAGE THE FOLLOWING PROPOSITION: PROPOSITION TO ISSUE WATERWORKS REVENUE BONDS OF THE VILLAGE OF ST. ELIZABETH, MISSOURI, TO THE AMOUNT OF \$110,000.00 FOR THE PURPOSE OF PAYING A PORTION OF THE COST OF CONSTRUCTING WATERWORKS TO BE OWNED EXCLUSIVELY BY SAID VILLAGE; DESIGNATING THE TIME OF HOLDING SAID ELECTION, FIXING THE POLLING PLACES OF SAID ELECTION, APPOINTING THE JUDGES AND CLERKS TO CONDUCT SAID ELECTION, PRESCRIBING THE FORM OF BALLOT TO BE USED THEREAT AND AUTHORIZING THE VILLAGE CLERK TO GIVE NOTICE OF SAID ELECTION.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. ELIZABETH, MISSOURI, AS FOLLOWS:

Section 1. That a special election be, and the same is, hereby ordered to be held in the Village of St. Elizabeth, Missouri, on Tuesday, May 23, 1967, for the purpose of submitting to the qualified voters of said Village the following proposition;

PROPOSITION

Proposition to issue waterworks revenue bonds of the village of St. Elizabeth, Missouri, to the amount of \$110,000.00 for the purpose of paying a portion of the cost of constructing waterworks to be owned exclusively by said Village, the cost of operation and maintenance of said waterworks and the principal of and interest on said waterworks revenue bonds to be payable solely from the revenues derived by said Village from the operation of its waterworks.

Section 2. That the Village Clerk of the Village of St. Elizabeth, Missouri, be, and he is, hereby authorized and directed to give notice of said election by causing to be published in the Miller County Autogram Sentinel, a weekly newspaper printed and published in the City of Eldon, Miller County, Missouri, and of general circulation in the Village of St. Elizabeth, Missouri, a notice of the time, places of holding and purpose of

said election, said notice to be published once a week for three consecutive weeks, the first publication of said notice to be made at least twenty-one days before, and the last publication to be within two weeks of the date of said election. Said election shall be held and conducted and the result thereof shall be canvassed in all respects in conformity with the Constitution and laws of the State of Missouri, and in accordance with all ordinances adopted by the Board of Trustees of the Village of St. Elizabeth, Missouri.

<u>Section 3.</u> That the ballots to be used at said election shall be in substantially the following form:

Instructions to voters:

To vote <u>in favor</u> of the proposition submitted upon this ballot, place a cross (X) mark in the square opposite the word "YES"; and to vote <u>against</u> the proposition submitted upon this ballot, place a cross (X) mark in the square opposite the word "NO".

PROPOSITION

Shall the following be adopted:

Proposition to issue waterworks revenue bonds of the Village of St. Elizabeth, Missouri, to the amount of \$110,000.00 for the purpose of paying a portion of the cost of constructing waterworks to be owned exclusively by said Village, the cost of operation and maintenance of said waterworks and the principal of and interest on said waterworks revenue bonds to be payable solely from the revenues derived by said Village from the operation of its waterworks.

<u>Section 4.</u> That at said election, the qualified voters of said Village shall vote at the following place: Community Center.

Section 5. That the following named persons are hereby designated

and appointed to act as judges and clerks of said election:

Section 6. That the Village Clerk is hereby directed to prepare and cause to be printed ballots as herein provided, and to prepare or procure the necessary poll books and tally sheets to be used at said election, and shall cause the same to be delivered to the judges of said election.

Section 7. That this ordinance shall be in full force and effect from and after its passage and approval.
