The Kingsbury County Board of County Commissioners met Tuesday, September 21, 2021, at 8:30 AM in the Courtroom in the County Courthouse with Commissioners Roger Walls, Kyle Lee, Steve Spilde, and Doug Kazmerzak. Chairman Walls presided.

#### PLEDGE OF ALLEGIANCE

Those present stood and recited the Pledge of Allegiance.

#### APPROVE AGENDA

### PUBLIC COMMENT
