HORSE RIDING & FARM ACTIVITIES RELEASE OF LIABILITY

Please read carefully before signing, this is a release of liability and waiver of certain legal rights. IN CONSIDERATION FOR MY PARTICIPATION IN ACTIVITIES INVOLVING HORSES, PONIES, HORSE TRAINING, OR INSTRUCTION CONNECTED OR RELATED TO CIRCLE A HOME FOR HORSES (CAH4H), the undersign agrees to the following:

I acknowledge that riding, handling or being near HORSES AND PONIES (EQUINES), and other outdoor environments where training or other horse related activities occur have inherent risks, hazards, and dangers that are impossible to eliminate.

I UNDERSTAND THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

- 1. The propensity of the animal to behave in ways that may result in injury, harm or death to people on or around them.
- 2. The unpredictable nature of the animal's reaction to such things as loud sounds, sudden movement, and unfamiliar objects, persons or other animals.
 - 3. Collision with people, or other animals.
- 4. The potential of the participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animals or not acting within his /her ability.

I understand the risks, hazards, and dangers described above. I also understand these activities may require good physical condition and a degree of skill and knowledge. By my participation, I have represented that I possess the physical conditioning, knowledge and skill necessary to engage in equestrian activities, farm and other related activities. I am in good physical health and have the ability to safely engage in the activities organized or sponsored by CAH4H.

I AM VOLUNTARILY PARTICIPATING IN ANY AND ALL EQUESTRIAN RELATED ACTIVITIES OR EVENTS ASSOCIATED WITH CAH4H WITH FULL UNDERSTANDING OF INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISK OF INJURY, ILLNESS, DISEASE, PARALYSIS OR FATAL INJURY.

Lastly, for myself, my heirs, successors, executors, and subrogates, hereby knowingly and intentionally WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS CIRCLE A HOME FOR HORSES, INC., its directors, officers, agents, instructors, employees, volunteers from and against any and all claims, actions, causes of actions, liabilities, suits, expenses (including attorney's fees) which are related to, arise out of, or are in any way connected to my participation in this activity, including but not limited to NEGLIGENCE of any kind or nature, foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, illness, disease or fatal injury to me or my property as a result of my engaging in these activities or the use of animals or equipment, whether such damage, loss, injury, paralysis, illness, disease, or fatal injury results from NEGLIGENCE of CAH4H or another cause.

I understand pictures and videos are routinely taken in, and around the horses and farm. I authorize CAH4H to use images I may be in, in any media, print ads, social media or any other platform of marketing or business development.

I HAVE CAREFULLY READ, CLEARLY UNDERSTAND, AND VOLUNTARILY SIGN THIS WAIVER AND RELEASE AGREEMENT.
