
Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

- Make driving more efficient (reducing mileage)
- Reduce the usage of electricity
- Promoting Environmental Management System
- Reduce the use of non-recyclable materials

We project that carbon emissions will decrease over the next five years to 2900 tCO₂e by 2026. This is a reduction of a minimum 14%

Progress against these targets can be seen in the graph below at the end of year 1 against the baseline.

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 1,358 tCO₂e, a 14%ge reduction against the 2021 baseline and the measures will be in effect when performing the contract

To date we have completed the following carbon reduction projects:

- Implementation of an environmental policy

In the future we hope to implement further measures such as:

- Travel Policy for reduction of emissions
- The use of renewable energy
- The supply and use of electric or hybrid company vehicles
