### **Vendor Applications & Payments Due by March 1st, 2024.**

Prior to the Event:

- Vendor Event Packets available March 25th, 2024.

Vendors will receive a packet containing a grounds map with their vendor spot marked, vendor bracelets for entry and a parking tag for expedited entry on event days — no bracelets or parking tags will be replaced.

- Food Trucks ONLY: Provide proof of current permit from Guilford County Department of Health and a list of the items being sold from the truck no later than March 1st, 2024

At the Event:

- Vendors must be in place with set up completed on the evening prior to the event start (3/29/24).
- All food trucks must arrive must remain in place each day. Under no circumstance may a vehicle move within the show grounds during the event.
- Vendors should collect their own waste at their location; a dumpster is available on site and event staff will make multiple pick-ups through out each show day.
- Potable water is NOT available on site. Any vendor serving food must supply their own water for food preparation activities.
- Generators are allowed unless the noise impedes the event (e.g., exhibitors unable to hear the ring announcer, continuous horse spooking)
