

3. That the school shall comply with the Provisions of Section 10(1) read with Rule 125 of DSEAR, 1973.
4. That the school shall observe the relevant provisions of RTE Act, 2009, DSEAR,1973 and directions/instructions issued by the Department from time to time.
5. That the school shall comply with the relevant orders/guidelines of DoE and judicial pronouncements w.r.t. utilization/maintenance of school's funds.
