# POLICIES

AT LEGACY, WE ARE COMMITTED TO CREATING A POSITIVE, RESPECTFUL, AND SUPPORTIVE ENVIRONMENT FOR OUR PLAYERS, COACHES, AND FAMILIES. TO ENSURE OUR PROGRAM OPERATES SMOOTHLY AND UPHOLDS ITS VALUES, WE EXPECT ALL PARTICIPANTS AND FAMILIES TO FOLLOW THESE GUIDELINES:

### 1. 24-HOUR RULE FOR ADDRESSING CONCERNS

TO MAINTAIN FOCUS DURING GAMES AND TOURNAMENTS, ALL PARENTS MUST WAIT AT LEAST 24 HOURS AFTER A GAME OR TOURNAMENT TO BRING ANY CONCERNS TO A COACH. THIS ALLOWS PLAYERS TO STAY FOCUSED ON THE COMPETITION AND GIVES COACHES THE SPACE THEY NEED TO CONCENTRATE ON THEIR RESPONSIBILITIES.

### 2. PARENT CONDUCT AND BEHAVIOR

THE WAY PARENTS BEHAVE REFLECTS ON THEIR PLAYERS AND IMPACTS THE TEAM. ANY INAPPROPRIATE ACTIONS OR ATTITUDES TOWARD OTHER PARENTS, COACHES, REFEREES, OR OTHER TEAMS AND THEIR FANS WILL DIRECTLY AFFECT A PLAYER'S PARTICIPATION.

- TECHNICAL FOULS FROM THE STANDS: IF A PARENT RECEIVES A TECHNICAL FOUL DURING A GAME, THEY WILL NOT BE ALLOWED TO ATTEND LEGACY GAMES FOR THE REMAINDER OF THAT TOURNAMENT OR SESSION.
- CHOOSE YOUR WORDS AND ACTIONS WISELY, AS THEY CAN HAVE SERIOUS CONSEQUENCES FOR YOUR CHILD'S PLAYING TIME AND THEIR PLACE IN THE PROGRAM.

# 3. ACCOUNTABILITY AND SECOND CHANCES

LEGACY BELIEVES IN SECOND CHANCES, BUT WE ALSO VALUE ACCOUNTABILITY AND DEPENDABILITY. IF A PLAYER DECIDES TO LEAVE THE LEGACY PROGRAM MORE THAN ONCE, THEY WILL NO LONGER BE ALLOWED TO PARTICIPATE. DEPENDABILITY AND COMMITMENT TO TEAMMATES ARE KEY PARTS OF OUR PROGRAM'S SUCCESS.

# 4. PLAYER BEHAVIOR DURING PRACTICE

PLAYERS ARE EXPECTED TO REMAIN FOCUSED AND PRODUCTIVE DURING PRACTICE. IF A PLAYER REPEATEDLY:

- FAILS TO FOLLOW DIRECTIONS,
- BULLIES OR DISRESPECTS TEAMMATES,
- CAUSES HARM TO TEAMMATES DUE TO LACK OF ATTENTION,
- OR ENGAGES IN BEHAVIOR THAT DISRUPTS THE TEAM'S PROGRESS.

THEY WILL BE REMOVED FROM PRACTICE. REPEATED INCIDENTS MAY RESULT IN REMOVAL FROM GAMES.

# POLCES

### **5. PARENTAL SUPERVISION AND COMMUNICATION**

COACHES ARE VOLUNTEERS AND CANNOT ACT AS BABYSITTERS OR PROVIDE FOOD OR CONSISTENT SUPERVISION BETWEEN GAMES.

- FOR GRADES K-5, A PARENT OR RESPONSIBLE ADULT MUST BE PRESENT AT THE GYM DURING BREAKS BETWEEN GAMES.
- IF YOUR CHILD NEEDS A RIDE OR OTHER CARE ARRANGEMENT, THIS MUST BE COMMUNICATED TO THE COACH AT LEAST 24 HOURS BEFORE GAME TIME.

### **6. RESPECT FOR FACILITIES AND TIME**

WE VALUE THE FACILITIES WE USE AND THE TIME SHARED AMONG TEAMS.

- PLEASE ARRIVE ON TIME FOR PRACTICE AND LEAVE PROMPTLY WHEN YOUR TIME IS OVER TO ENSURE SMOOTH TRANSITIONS.
- IF YOU ARRIVE EARLY, PLAYERS MUST WAIT TO BEGIN SHOOTING OR WORKING ON THE COURT UNTIL GIVEN PERMISSION BY A COACH.

### 7. BILLING AND DEPOSIT POLICY

- EVERY PLAYER MUST PAY THEIR DEPOSIT TO SECURE A SPOT ON THE TEAM. FAILURE TO DO SO WILL RESULT IN REMOVAL FROM THE ROSTER, AND THAT SPOT MAY BE OFFERED TO ANOTHER PLAYER.
- PLAYERS WHO MISS PAYMENT DEADLINES MAY BE REMOVED FROM PRACTICES AND GAMES UNTIL PAYMENT IS MADE.
- IF A SEASON IS CANCELED DUE TO NON-PAYMENT, ALL FUNDS ALREADY PAID ARE NON-REFUNDABLE.
- PLAYERS WHOSE SEASON ENDS EARLY DUE TO INJURY OR MOVING MORE THAN 50 MILES AWAY WILL BE ELIGIBLE FOR A PRORATED REFUND BASED ON UNIFORM, PRACTICE, TOURNAMENT, AND ADMINISTRATIVE COSTS.

# 8. RESPONSIBLE CONTACT REQUIRED

A RESPONSIBLE PARENT OR GUARDIAN MUST BE ON FILE AND IN COMMUNICATION WITH COACHES BEFORE A PLAYER MAY PARTICIPATE IN ANY LEGACY PRACTICES, GAMES, OR EVENTS. WE MUST HAVE UPDATED CONTACT INFORMATION AND AN ACTIVE POINT OF COMMUNICATION FOR EVERY PARTICIPANT.

# 9. SCHOLARSHIP PARTICIPATION REQUIREMENTS

ATHLETES RECEIVING A SCHOLARSHIP THROUGH THE LEGACY PROGRAM ARE EXPECTED TO ACTIVELY PARTICIPATE IN ALL TEAM FUNDRAISING OPPORTUNITIES, INCLUDING EVENTS LIKE POPCORN SALES, FILL-THE-CALENDAR CAMPAIGNS, AND RAFFLES. THESE EFFORTS HELP MAKE SCHOLARSHIPS POSSIBLE AND ENSURE SUPPORT FOR ALL ATHLETES IN THE PROGRAM.
