Sincerely, HCP1HOA **Board of Directors Board Meeting:** The first Open Board Meeting was held on March 14th with approximately 15 Homeowners attending. If you are interested in seeing what was discussed, the minutes are posted on our website. **2020 HOA Picnic Cancelled:** Due to the lack of Homeowner response to volunteer for a committee to help us plan and work on the picnic and the COVID 19 issue, the 2020 picnic has been cancelled. Speed Limit: Many vehicles have been observed exceeding the speed limit, especially on Mainline and High Country Drive. Please remember that the limit is 25 mph within the **community.** Also, <u>ABSOLUTELY NO VEHICLES</u> are allowed in the Green Belt area of High Country Pines, Phase 1 or Phase 2. **<u>Dogs-at-Large:</u>** Navajo County Ordinance and our C,C,&R's prohibit unleashed or uncontained dogs in our community. Please keep your pets on a leash or confined to your property. Also, pet owners are required to pick-up after their pets.
