# HEADLIGHTS

Based on the attendance at the March 12<sup>th</sup> swap meet, the weather cooperated by providing sunshine, but enough chill in the air to keep people from doing outside chores. Peter Weiglin did an admirable job in his first solo appearance as event organizer. There were lots of Division 7 members there on Friday to set up the tables and help the early arrival vendors get their merchandise carted into the building. On Saturday there was a large crowd of people waiting for the gates to open. It seemed to me like the gym and the sales area out in the hall retained their "heavy crowd" condition longer than in years past. Like many other people, I parted with some items that no longer fit, and acquired some items that did fit the current layout plan. (You know, that layout plan that's still on paper and in my head.)

Back in 2015, the membership voted on and overwhelmingly approved a new set of regulations for the division. These regulations were intended to go into effect when Division 7 became a 501(c)3 corporation under an umbrella classification of the NMRA national organization. Since we're not sure how long it will be before we're able to convert to that corporation, the Division BOD feels that it would be wise to update the organizing documents for our current 501(c)4 corporation.

At the division BOD meeting on March 3<sup>rd</sup>, Mike Brestel and Frank Koch presented a proposal for a revised set of regulations to govern our current organization. There was much discussion revising and clarifying the wording in the proposal to get it precise. At times, it reminded me of the scene from the musical "1776" where they are making revisions to the first draft of the Declaration of Independence. Fortunately, there were no accusations of the Superintendent being a tyrant. The BOD voted and approved the proposal as modified during the BOD meeting. Mike then updated the new regulations with those modifications and distributed them to the BOD members. Further review and many emails led to more clarifications and updates. It was then decided a new BOD vote was needed to approve the final version of the proposal. This vote took place at an emergency meeting of the BOD at 9:40 am on March 11<sup>th</sup> at the Swap Meet. This vote also resulted in approval.

So, what's changing? The biggest change is that we added language suggested by the IRS during our recent audit. Another major change is to make the Secretary and Treasurer positions appointed rather than elected. Recent experiences have shown us that there are advantages to appointing rather than electing a Treasurer, and it makes no sense to dump him or her after four years if he or she is competent and willing to continue. The same is true of the Secretary's position. Appointing these two positions matches the way National successfully handles the situation.

There are many other small changes, things that we've talked about correcting or changing over the years but never gotten around to doing. Two of the changes were mandated some years ago by the MCR, but we never made them. They are included in this update. We also included provisions for increasing procedural flexibility in some areas and allowing electronic voting in the future. In addition, we updated the section that deals with officers and their responsibilities, and worked to make some of the language easier to understand.


We will present an overview of the proposal and answer questions at the April meeting. In late April all Division 7 members will receive via US mail a copy of the proposed regulations and a ballot to vote on their approval. Because of the change in status to the Treasurer and Secretary positions, it is necessary to adopt these new regulations before the regular elections at the end of 2017.

Some passings of note: Former Division 7 member Jim Sicking passed away on February 12<sup>th</sup>. Division 9 Superintendent Gary Burdett, MMR passed away March 15<sup>th</sup>. Both will be missed.

### Looking ahead:

Our next regular meeting will be on Sunday April 9<sup>th</sup>, at Harmony Lodge in Winton Place (Spring Grove Village). This is actually a joint meeting with the Cincinnati Railroad Club. We have a special clinician for this event - Michael Abraham, from Blacksburg Virginia, who is the author of a new book called "Chasing the Powhatan Arrow; A Travelogue in Economic Geography." See the attached synopsis of this presentation. His book, Chasing the Powhatan Arrow, as well as his prior seven books, will be available for purchase. Layout visits will be to the O Scale Cincinnati Model Railway Club there at Harmony Lodge and to Dan Hadley's HO Sierra Northern layout.

On May 7<sup>th</sup>, [ note: first Sunday – to avoid Mother's Day ] we will be returning to West Chester Library for our monthly meeting. (For the avid readers of this column, you will realize that scheduling the visit to Cinder Sniffers in June caused some juggling of our meeting locations on the calendar. Not to worry, we are "back on track".) Our May clinician will be Peter Weiglin, who will be talking about railroad mail service. Our layout visits will be to John Burchnall's, to view the Eastern Loggers HO layout, and to Dave Puthoff's HO C&O.

Also in May is the Mid-Central Regional Convention, "The Pan American", which runs May 18-21 in Louisville. The Galt House downtown is the convention hotel. There is a link to the information about the convention on the MCR website (which you can get to from our Division 7 website).

In June, as mentioned, we have arranged with the Cinder Sniffers for them to host our members at their June run on their large scale/live steam layout in Southeast Indiana. That will be on <u>Saturday</u> June the 10<sup>th</sup>. This will be in place of our regular monthly meeting. Be sure to adjust your calendar to reserve this Saturday in June.

In July (7/9), we will be up north in Mason at St Susanna Church. Terry Luginbuhl will be back as clinician with a second clinic on DCC. Current thinking is that the topic will be how to do "consisting". As previously talked about, the subject can be selected based on your feedback. So if consisting is <u>not</u> what you would like to hear about – Let Me Know! Voting is still open.

Between our July and August meetings, the NMRA National Convention will take place in Orlando. The dates for this year are July 30<sup>th</sup> through August 6<sup>th</sup>. Our August meeting is on the 13<sup>th</sup>. We will meet at Good Shepherd in Kenwood, with Ed Swain giving a clinic on building with styrene. In September, we will be at the Anderson Senior Center and in October, we will be at the Erlanger Library. We are in discussion to have a joint meeting with Dayton Division 3 in November.

## APRIL CLINIC PREVIEW - Chasing the Powhatan Arrow

A Travelogue in Economic Geography Presentation by Michael Abraham


From its inception in the 1880s, The Norfolk and Western Railway was primarily a freight carrying company, principally conveying coal from the central Appalachian coal fields in Virginia, West Virginia, and Kentucky to the eastern seaboard port of Norfolk and to Cincinnati for transfer to the steel mills and power plants of the Great Lakes region. But as a sideline, it always provided passenger service as well. A profitable, well run company, N&W only accepted the very best.

As World War II ended, N&W provided several named trains along its main line, including the Cavalier, the Pocahontas, and its daytime flagship the Powhatan Arrow. Pulled by the magnificent Class J steam locomotives that N&W manufactured at its Roanoke Shops, the Powhatan Arrow provided fast, luxurious, and memorable service for over two decades before passenger service gave way to automobile and airplane travel nationwide.

The corridor traversed by the Powhatan Arrow is a wonderfully complex, geographically fascinating, socially diverse, and economically mixed path through Virginia, West Virginia, and Ohio. The vicissitudes of time have endowed the communities along the way with a broad spectrum branching from success to failure.

With the N&W line no longer carrying passengers, author Michael Abraham duplicated the route as closely as possible by car, motorcycle, bicycle, and even canoe, gathering each area's history and culture and profiling entrepreneurs, railroaders, historians, rail fans, and everyday people in this entertaining, educational, enlightening, and humorous look at a swath of America's past, present, and future.

Chasing the Powhatan Arrow contains enlightening stories from interviews with railroad executives, historians and community leaders, as well as compelling discussions of railroad technology and history. Michael's presentation includes the genesis of his project, entertaining highlights, a discussion of the findings and conclusions, and a few excerpts from the book. He will be available following the presentation for questions and discussions. His book, Chasing the Powhatan Arrow, as well as his prior seven books, will be available for purchase.


