I have attached the letter regarding 2021 3rd qtr. payroll for \$5,000 that was deposited into the wrong account.

Apparatus/ Equipment

All our trucks are in good shape, and up to date on services and DOT inspection's.

Tanker 4 is starting to show its age with maintenance and upkeep. Have not tested the pump due to its age and knowing it will fail its test. FEMA grant replacement is in for this truck, should be hearing on the results in later November FEMA dependent.

Have schedule our pump testing with Lenawee County for Engine 5 and Ladder Truck 21. This is an annual test performed on the trucks. We join in with other departments in the county to get a lower rate. The date for pump testing is November 14th at Adrian City.

Ladder 21. Power steering has blown out a seal and leaking power steering. Took the truck to Jordon, our mechanic in Deerfield and he stated the power steering pump had gone bad. For parts and labor, the cost should not exceed \$1,000. Parts have been ordered and will be replaced later next week. The truck is still in service, just must keep an eye on the oil level.

Also, while the truck is in for repairs, he will rebuild an arial valve that is in rough shape and leaking from our water that tends to leave build up of calcium.
