You must complete this waiver & declaration prior to or upon visiting Kennebec Family Retreats and before taking part in any activity.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is known to spread by contact from person to person. Consequently, local, provincial, and federal governmental authorities recommend various measures and prohibit a variety of behaviors, to reduce the spread of the virus. Kennebec Family Retreats and its members comply with the requirements and recommendations of Ontario National, Provincial, and local Public health and other governmental authorities, and to put in place and adopt all necessary measures to that effect. However, Kennebec Family Retreats cannot guarantee that you or any member of your household will not become infected with COVID-19. Further, attending the Activities could increase your and members of your household's risk of contracting COVID-19, despite all preventative measures put in place.

By signing this document,

- 1. I acknowledge the highly contagious nature of COVID-19 and I voluntarily assume the risk that I, and members of my household could be exposed or infected by COVID-19 by taking part in Kennebec Family Retreats' activities. I am aware that COVID-19 exposure and infection may lead to injury, disease, other illness, or death.
- 2. I declare that I, and all members of my household, are taking part voluntarily in Kennebec Family Retreats' activities.
- 3. I declare that neither I nor anyone in my household have experienced cold or flu-like symptoms in the last 14 days (including fever, cough, sore throat, respiratory illness, difficulty breathing).
- 4. No one from my household will attend Kennebec Family Retreats if anyone in my household experiences cold or flu-like symptoms, or Covid-like symptoms including new or worsening cough, shortness of breath or difficulty breathing, temperature equal to or over 38°C, feeling feverish, chills, fatigue or weakness, muscle or body aches, new loss of smell or taste, headache, shortness of breath, coughing, gastrointestinal symptoms (abdominal pain, diarrhea, vomiting), and/or feeling very unwell.
- 5. No one from my household will attend Kennebec Family Retreats or take part in its activities or programs until at least 14 days have passed since the household member experienced Covid symptoms.
- 6. KFR may waive the 14-day waiting period at its discretion if you supply proof of a negative Covid test for all members of my household taken within 48 hours of arrival at Kennebec Family Retreats.

- 7. No one in my household has travelled to or has had a lay-over in any country outside Canada, or in any Province outside of Ontario, in the past 14 days. If I travel, or if anyone in my household travels outside the Province of Ontario after submitting this declaration, I, and all members of my household, will not attend any of Kennebec Family Retreats' activities, programs, or services until at least 14 days have passed since the date of return.
- 8. I, and all members of my household agree to adopt all the requirements and recommendations of National, Provincial, and local Public health and other governmental authorities and to those special safety regulations put in place by Kennebec Family Retreats as it pertains the Covid-19 Coronavirus.
- 9. I, and all members of my household, agree that, by filling out and signing this waiver and agreeing to the terms and conditions set out in it, I am giving up my legal rights to sue Kennebec Family Retreats and its officers and directors, if I, or any member of my household, contracts the Covid-19 Coronavirus.
- 10. I agree that willful non-compliance with Covid guidelines will result in immediate dismissal with no refund.

This document will remain in effect until Kennebec Family Retreats, and national, provincial, and local government health officials decide that the acknowledgments in this declaration are no longer needed.

This document is in addition to and does not replace all other Kennebec Family Retreats' waivers and contracts.
