- Dust Coating Quotes – Crow River Const. stated 2022 we did .25 application rate per Crow River Concrete. 2 Quotes received. - Crow River Construction - .385/ft for 9” Road, .553/ft for 12” road & .832/ft for 18’ Road & Kevin Loftness LLC - \$0.95 for 20 ft spread. After some discussion, Brent Uecker made a motion to accept the quote from Kevin Loftness LLC. 2nd by Craig P. Carried
- 202nd Circle by Hwy 15 – After some discussion that there needs to be a ditch or something cut in the rite-of-way on the south side of the road, it was decided that the Supervisors would look at it when it dries up more and Brent said he would try to get a couple contractors to take a look also.

- Resident at 24827 Hwy 15 N contacted Craig P and stated that someone mowed his whole ditch – more than the rite-of-way. It is thought that this was the State, not Matt W for the Township. The Clerk is to contact Matt anyway and let him know not to mow more than the top cut on the property on the north side at the corner of Hwy 15 and 247th St.

- Memory Circle – Mike Edberg – Came to make sure all of Memory Circle got dust coated. He asked if the Township would be willing to share in the cost. Brent told him that the Township can’t offer any discount or payment as they would have to do the same for everyone then. Mr. Edberg asked he be contacted if the residents are short as a few have not paid yet. The Supervisors said payment must be received prior to the dust costing being applied or the Township would only apply what was paid for.
