

## Keeping Elohim's Law: Exodus 21-23

1. 1 John 3:4 (Sin is transgression of God's law [His Commandments] AKA the Royal Law)
2. Matthew 5:17-20 (Jesus did not destroy the law)
3. Matthew 22:35-40 (The Royal Law or Ten Commandments can be summed up in these. Also all of God's Law/Commandments can be summed up in the 10)
4. 1 John 5:1-3
5. 2 John 5-6
6. James 2:8
7. Romans 13:8-10
8. John 14:15\_21
9. Romans 3:27-31 (Works/Deeds of the Law=Sacrificial/levitical Law that cannot justify you. Established Law=Same Jesus mentioned Matthew in 5:17-20 the Royal Law)
10. Romans 7:7-12 (In order to know what sin is you must know the LAW)
11. Exodus 21:1-11 (Law dealing with employees/servants etc...)
  - Verses 2-3=This is where Britain got it's indentured servitude laws from. In today's terms: When you become a wage laborer whatever you came to job with is what you shall leave with.
  - Verses 4-6=Whatever was acquired from your employer outside of promised wages for labor rendered shall belong to your employer. For example when you came in you did not have healthcare. When you leave you shall not have healthcare anymore.
  - Verses 7-11=Do not sleep with your secretary. If you do you just got a new wife and you must treat her equal to any other wives you may have. Do not fire the secretary after smashing. If you live in the non-westernized world just take the passage literal.
  - These are covered by the ten commandments laws 8-10/Exodus 20:15-17
12. Matthew 20:1-16
13. Exodus 21:12-36 (Law dealing with violence against others)
  - Verses 12=If you murder someone you shall be put death
  - Verses 13=If you run a fade and are victorious by fatality then you shall not be put to death. A safe place for you to live is required where the friends and family of the loser cannot get you. See Numbers 35:10-34
  - Verses 16=Kidnapping
  - Verses 18-19=If you fight with someone and injure them than you shall pay them for lost wages and cover their hospital bill. God's law doesn't not really deal with prison sentences. That is gentile non-sense.
  - Verses 20-21=Do not kill your employee
  - Verses 22-23=If your unintentional actions lead to accidentally harming a pregnant woman and cause her to give birth prematurely; than you shall receive whatever punishment her husband deals you as well as whatever the government levies against you. If you cause her to miscarriage or lose the baby then you shall be put to death.
  - Verses 26-27=If you permanently injure an employee or someone who owes you something then their debt shall be forgiven or you shall release said employee and pay them.
  - Verses 28-32=If your animal unintentionally kills someone that it shall be put down. If intentionally does so than both it and it's owner shall be killed. If your animal kills someone's employee then you shall pay the employer for loss of wages.
  - Verses 33-34=If your home improvement or construction project causes the loss of someone else's property you shall pay them for it.
  - Verses 35-36=If you get into a vehicle accident the person who hit you shall sell their car and split the money with you. You will sell your vehicle as well and split the money. If the person has

a history of accidents or intentionally hits you then they shall pay for everything. If you live on a farm with animals then take literal.

#### 14. Exodus 22

- Verse 1=Whatever you steal you shall payback with interest
- Verses 2-4=If you shoot/kill someone trying to rob you you have done nothing wrong. If the thief gets away he shall make full restitution and if he has nothing he shall work off his debt. If he is found with the stolen goods he shall return them to the owner with double.
- Verses 5-6=Do not destroy your neighbor's property, Do not commit arson. If you live on a farm, take it literally.
- Verses 7-8=If you are found with hot goods knowingly then you shall be punished the same as the thief.
- Verses 10-15=If you lend an item to someone and they break or lose it at no fault of their own then they do not have to repay you back. If it is intentionally broke or lost or they knowingly took an action that they knew could potentially do that then they must repay you back.
- Verses 16-17=If you mack a chick to smash then you shall marry her. No smash and dash or hit and quit. If her Father who is her head covering refuses to let you marry her than you shall make payment to her family. See Numbers 30:3-5
- Verse 21=Do not rob the central americans in your hood because they are illegal immigrants and do not have bank accounts so they carry cash and you figure they are easy targets to rob.
- Verse 22-24=Do not oppress Taquisha and her fatherless children. If you do Yah will cause the same to happen to you. This is why we now have gentile broken homes in large numbers in the United States.
- Verse 27=Repay what you owe at the time appointed
- Verse 28=Do not curse president Trump. So no "F" Donald Trump songs. See 1 Timothy 2:1-4, Hebrews 13:17, & Romans 13:1-5
- Verses 29-30=Pay your tithes and offerings when you first get paid
- Verse 31=Do not eat roadkill

#### 15. Exodus 23:1-9

- Verse 1=Stop spreading fake news and misinformation. If you do not for sure if it is true then do not spread it. See Psalms 120:1-4 & Proverbs 17:4
- Verse 2-3=Do not run to see a fight or any other wickedness. Do not stir up trouble. Do not show favoritism to the poor. God is not a respecter of persons.
- Verses 4-5=If you see your enemy's property, family, etc.. in trouble then help them. Use Step father in law example on wedding day.
- Verse 6=Do not not show favor to the poor just because he is poor.
- Verses 7-8=Stop snitching. Top taking plea bargains and snitching. Stop avoiding jail time by snitching.
