OTHER INFORMATION

Compactor Installation – The unit is typically mounted to a wall close to the garbage compactor. A 2" diameter hole is drilled into the compactor hopper. A hose is installed over the outlet of the vaporizer unit and then routed to the inside of the compactor. As the unit runs, vaporized odor neutralizer is blown inside the compactor where it builds up and eliminates odors.

Chute Installation – the unit is typically mounted on a wall close to the outlet of the chute. The natural chimney effect of a garbage chute draws the vaporized odor neutralizer up the chute eliminating odors at the base of the chute and within the upper sections of the chute. One unit can service 20 floors. Additional units can be installed on the upper floors of taller buildings.

Open Installation – For garbage dumpers, trash can areas and general trash rooms, the vaporizer is mounted above the top of the trash receptacles, the vaporized odor neutralizer builds up within the room. Ventilation should be minimized to retain the vaporized odor neutralizer inside the room. Mounting Options – The unit can be mounted to a wall, mounting tabs are supplied, it can also be installed on uni-strut, a mounting pedestal is also available. The unit does not have to be mounted; it can run just sitting on the floor.

Cycle Times – The unit comes preprogrammed to run for 30 seconds and remain off for 30 minutes. This is normally sufficient for most odor control requirements. At this setting a 5 gallon pail of odor neutralizer will last over 12 months. Cycle time adjustments are easy to make on the control panel. Electrical Costs – \$10 per year. Runs only one minute per hour. Runs on any standard 115 VAC electrical outlet. Draws 6 AMPS when running. Tamper Proof – The cover of the Digital Control Panel can be padlocked to prevent the unit from be tampered with. The cabinet door has a lock. Superior Construction – Made in the USA, Stainless Steel and Lexan construction plus proven industrial quality components ensure reliability and durability even in the toughest operating environment. The unit can be installed inside or outside.

Simple and Fast Installation – Very easy for any maintenance person to install. Starting the system is as easy as placing the 5 gallon pail of Piian Odor Neutralizer inside the lower cabinet and pushing the start button.

Easy To Use – A digital control panel insures full automation and allows simple adjustments, easy to understand.

Low Level Indicator – An LED on control panel alerts user to low liquid level. An alarm will sound when the odor neutralizer needs to be replaced. **High Humidity Operation** – the system does not use water allowing high performance even in high humidity conditions.

Freezing Operation – can be configured to operate down to -50°F.

Standard One Year Warranty - the system comes with a full one year warranty. (Full warranty details available by request).

Lifetime Warranty Option – Each year that you purchase a 5 gallon refill of Piian Odor Neutralizer, we will extend your system's warranty by 1 year effectively giving a lifetime warranty on the system. (Full lifetime warranty details available by request).

ABOUT OZONE GENERATORS

Ozone Generators are commonly used for garbage odor control – however they must run 24 Hours per day, even a small ozone unit will consume over \$1000 of electricity per year, often much more.

Ozone Generators have a short lifespan and require expensive replacement parts and labor – often within 2 years.

To be effective, Ozone generators must exceed the safe limit for ozone exposure to employees as defined by the US EPA.

The US EPA has classified Ozone as a pollutant and human irritant.

Ozone eats up anything containing carbon, this includes the hoses and rubber seals on your garbage compactor.

ABOUT PERFUME SPRAYERS

Perfume spray systems dispense fragrances that are often toxic, obnoxious and functionally ineffective.

They require frequent refills, causing interruption, planning and expense. Their cheap design makes them unreliable, they are rapidly discarded. Perfumes and masking agents lead to secondary odor complaints as humans will associate the fragrance produced with garbage.
