

Historian; "Blurbs Blog": Greenwich, A Brief History Part IV. ...This is the continuation about the town of Greenwich, NY. All historical information below is gathered from various internet sources, town historians, Wikipedia, and so forth.

History of Greenwich

Hamlets within the Town of Greenwich

Bald Mountain: The hamlet of Bald Mountain, situated at the western base of the mountain, is two miles from Middle Falls. It once boasted two hundred residents when it was the center of the thriving lime industry. Lime was burnt there as early as 1768. Commercial manufacture of lime reached its peak in the 1850's when Robert W. Lowber headed a company there. Lime was transported over a macadam road that Lowber had built to the canal, three miles distant. The lime industry was sold in 1872 and production never resumed to its former levels. Gradually some of the 100 houses of the workers were moved to Clarks Mills. Bald Mountain is now known for its farming.

Battenville: A hamlet on the south town line located by the Batten Kill. It was settled in 1815 when a woolen mill was built there. This was later converted to a cotton mill. In 1872 the Phoenix Paper Mill was built on this site but it was destroyed by fire in 1921. It was rebuilt and is now the site of the Bio-Tech Paper Mill. The home where Susan B. Anthony spent part of her formative years has since been restored as has the adjoining building which served as a tavern and stagecoach stop.

Cossayuna: A hamlet located south of Cossayuna Lake in the northern part of the town. Originally known as Hog Hollow and later as Lakeville, the hamlet was settled in 1765 and was likely its first center of trade. Water power was developed at the outlet of Cossayuna Lake and three dams erected.

Among the mills located there were a blanket factory and a cheese factory. Famous for its bass fishing, it was one hundred years after the first settlers arrived before it became known as a resort.

Center Falls: A hamlet (previously known as Franklin and as Hardscrabble east of Greenwich village on NY-29 by the Batten Kill.

Clarks Mills: A hamlet in the southwest corner of the town by the Batten Kill.

Thomson: A hamlet northwest of Clarks Mills, by the Hudson River. The hamlet's notoriety has transitioned since its establishment from that of saw milling to paper milling.

Clarks Mills and Thomson are the perhaps the most historic part of town. Early records indicate a mill at this site was improved circa 1731. They both lie near the Great War Trail. In 1830 Hiram Clark purchased and expanded the mills at this site, hence the name. Carhard and Van Valkenburg established a planing mill there during the same time period. These businesses flourished for more than fifty years. In 1891 I.C. Blandy and three associates bought land on both sides of the kill, built a dam and in 1904 opened a pulp mill. Later they established a paper mill which is still in operation and is now known as Hollingsworth and Vose Co. Thomson was at first known for saw mills and later for paper companies. New York State Governor, John A. Dix, built a home that still stands. It later became the home of the Schuyler Preparatory School for boys.

East Greenwich: The town's oldest hamlet, located in the southeast part of the town located along the Batten Kill. Once known as Slab City, it has been home to several factories.

Greenwich: A village at the south town line and Batten Kill. The village is partially in Greenwich and partially in the town of Easton.

Middle Falls: Middle Falls' early development was also as a result of the Batten Kill's natural fall at that place. The drop is forty-five feet at Middle Falls. Just below is Dionondohawa Falls with a drop of ninety-five feet. Formerly known as Galesville and before that as Arkansaw, Middle Falls took its present name in 1875. The first settlers were Judge Nathan Tefft and his sons, Stanton and Nathan II. They migrated from South Kingston, R.I. and settled on what is now the Battenkill Country Club flats. Middle Falls has had many mills. The former Stevens and Thompson Paper Co. is now the Wisconsin Tissue Co. and the American Tissue Co. Diondehowa Park was once a recreation area that drew tourists from great distances, many of whom arrived by trolley.

North Greenwich:

A hamlet near the north town line. The community was formerly known as Antioch and Reid's Corners. The hamlet played an important role in the early town. A school was built around 1800 and a post office was established in 1850. The hamlet served as a stagecoach stop between Albany and Whitehall. Phineas Langworthy settled there in 1795. Washington County's largest apple orchard was planted in 1850 on the present Reid farm.

More General Info:


Recreation has changed somewhat through the years but the Batten Kill still provides swimming at the town-owned beach as well as tubing, rafting, fishing and more! There are hills and open fields for sledding, skiing, and snowmobiling. Tennis courts, a near-by country club and golf courses lend variety to the choices.

The village has always been a trading center for those in the surrounding countryside. In addition to a full complement of retail stores and a wide variety of dining establishments, there are three banks and several real estate offices. In 1974 a shopping center opened just west of the village. The Town also has several retail stores, car dealerships, restaurants and agri-businesses.

A history of Greenwich would not be complete without mention of the many people who achieved fame. Many talented lawyers, doctors, governors, senators, actors, circus performers, grand opera singers, writers, and artists have called Greenwich their home. Below are some of the more famous.

- [Susan B. Anthony](#) - Women's rights activist spent her childhood in Greenwich.
- [Chester A. Arthur](#) - Lived in Greenwich briefly before becoming the 21st President of the United States
- [Henry T. Clarke, Sr.](#) - Nebraska territorial legislator
- [George Henry Corliss](#) - Inventor of the [Corliss steam engine](#) grew up in Greenwich.
- [David Edward Cronin](#) - Painter and illustrator was born in Greenwich.
- [Laura Don](#), born Anna Laura Fish - actress-manager and playwright, died at her parents Greenwich residence in 1886.
- [Daniel Hall](#) - Wisconsin state legislator
- [James Howard Kunstler](#) - American author, social critic, public speaker, and blogger currently residing in Greenwich.
- [Grandma Moses](#) - Renowned American folk artist was born on a farm in the Town of Easton.
 - [Hal Ketchum](#) - Country music star & member of the Grand Ole Opry was born in Greenwich.
 - [Phantogram \(band\)](#) - electronic music duo, formed in Greenwich

Safety Officer; Jake Delgaudio: “June 2017 Blurbs Blog”!

Single File: The MSF recommends that when riding through “twistie’s”, (those turns in the road that are not gradual but rather more accentuated, and usually marked as 30 MPH or slower) we should be riding in “single-file”. This allows full lane use to each rider to navigate the best path for themselves.

Fingers: When the road captain leading ride holds up 1 finger (no not THAT finger, the index finger!) it means to ride single-file. When holding up 2 finger’s it means to ride normal staggered formation. However you can break formation as you need to, to get around bad pavement, pot holes and any other such obstruction that compromises your safety whether instructed to do so or not. Also note, be sure to remain in whatever formation your road captain indicates until such time as instructed to change it!

Dehydration: Water, Water, Water!!!! Remember to hydrate during rest breaks on rides and stop often! Dehydration can happen very fast in the hot days of summer and with it comes slower reflexes and slower reaction time. Be safe...drink WATER!!!

Braking: If you lock your front brake you lose ALL steering control. If you lock your rear brake you lose stability for about 80% of your motorcycle. If you can stop fast enough without locking your brakes you should obviously do so. The odds of

dumping your bike are many times greater if you lock your brakes (either of them) than if you do not. Stopping performance is a function of your brakes, your tires, and the road surface. Make sure to keep them all in good working order. Not sure what to do? **Take your bike to McDermott’s and get a “check-up”!**

Road Shadows: Be careful of road shadows (When on bike or in car)! If not sure what they hold...**do NOT move until you can be 100% positive it is safe.** If need be remove dark glasses so you can see better. *Make No Compromise* on this. Dark vehicles in dark shadows especially in turns or on tree lined roads can be almost impossible to see with only a quick glance. STAY PUT until safe to go!

Reminder: When stopped, remember....Just because the bike in front of you pulls out does NOT mean it is safe for you to do the same. Look good, make sure you are safe, and go.

Group Riding: When riding in a group you have a responsibility to watch those riding behind you also! If you see someone from the group (behind you) has pulled over or is missing, remember to find a *safe spot* and pull over! In this way, eventually the road captain leading the ride will see they are missing people, pull over, and investigate the situation!

Photographer: Bruce Tubbs:

This month I am offering something a bit different for those of you who like to record where you have been and what you see on your journeys. As you look at what you photograph, have a more critical eye and use some of these ideas to make better pictures.

1. **Get closer.** As a famous photographer once said, "If your pictures aren't good enough, you're not close enough." as you get closer to your subject, the more detail can be captured.
2. **Think about your light not the view.** Your eye is much more adaptable than your camera lens and what you see is not necessarily what your camera will produce so be aware of where your light source is coming from.
3. **Consider the time of day.** Sunrise and sunset are the best time to shoot. The light is "softer" and the results are amazing.





4. Change your composition by turning your camera on the side and take a vertical shot.
5. Fill your frame. The interesting parts of your scene should start on the left edge of the viewfinder and end on the right....this will also cut out any unwanted fluff in your pictures.

Play around with your camera and try some of these suggestions and see what the results can be. I look forward to seeing the results. Have fun shooting.
