**AFG/SAFER/DOT/CIH Grants update:** We interviewed one applicant for the CIH position and offered the position. Start date is still 8-10 weeks out due to training requirements.

### **NEW BUSINESS:**

**Fuels Grant:** We were awarded a DNRC grant for a fuels mitigation program. We requested \$290,000 and were awarded \$150,000. This will be allocated to a project in the Yellowstone River Ranch estates subdivision between Columbus and Reed Point. This is expected to be a 2-year project, starting in March with a completion goal of August 2024.

**Computer Updates:** Lisa worked with Dell to get some pricing discounts on an order for 4 new desktop computers. They are on order now and should be in soon.

Ambulance Remount: Looking at how long it takes to get a new ambulance, we would like to investigate remounting A4. We don't have cost information at this time but would estimate it to be in the \$120,000 range, compared to a new ambulance in the \$250,000 range. Deb made a motion to start exploring the process and costs involved. John seconded the motion, motion was approved unanimously.

Caterer approval for appreciation dinner: Travis received only one quote back from the caterers he reached out to for our appreciation dinner. R Heart Catering quoted \$25 per person for a split chicken/steak dinner. Chuck moved to approve R Heart Catering, Debbie seconded the motion. Curt did not participate in the vote, all other members approved, and the motion passed.
