Now I need to speak to the area about my findings at our NY region meeting. This has to do with our monthly donation to the region. As everyone knows, Staten Island area donates \$200 every month to the region (RSC). That is our standing policy, and a check is written at the beginning of each month and mailed to the regional office.

The issue I discovered is the way the treasurer report is given when it comes to donations. (There are copies on the table for all to see). I questioned the fact that the report only shows every other month. Region meets as you can see every other month, so the report is reflective of that. My question to the treasurer was where are Staten Island's donations for the months we don't meet at region and why aren't they reflected on the report. Why is the month of February, April, June etc. not on the report.

Doesn't the Region do business on those months and if not, why aren't our donations doubled? Nowhere does it show a donation of 400 dollars. There should be an overlap.

So Ed the treasurer and I have been speaking and texting. He is new at the position but was the treasurer for the regional service office before this. So all this to say, the responsibility of proving we sent checks is on us. Pat our treasurer has provided me with copies of the cashed checks. I have scanned and emailed them to Ed.

At this time, there is our check from this May that isn't cashed yet. And there is a check from November that was made out to the RSO instead of RSC which Pat can expand on. Also, there is a check from December that wasn't cashed at all. We pulled all the checks from a year ago to today. All checks show cashed except for those mentioned. My concern is that all the checks that were cashed are not on record at the Region. I'm hoping to hear back from Ed soon and this issue can be resolved. Im sure you have questions and I will do my best to answer them.
