1. **Waiver and Release.** I hereby agree not to sue and irrevocably and unconditionally release, waive, and forever discharge and hold harmless WONDER&WANDER and its successors and assigns from any and all liability, claims, demands and causes of action, of whatever kind or nature, either in law or equity, whether known or unknown, which I or the Volunteer, if different, ever had, now have, or which may hereafter arise from the participation of the Volunteer with WONDER&WANDER

and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER. I understand and acknowledge that this Release discharges WONDER&WANDER from any liability or claim that for the Volunteer, if different, may have against WONDER&WANDER with respect to any bodily or other injury, illness, death, or property damage that may result from the participation of the Volunteer. I also understand that WONDER&WANDER does not assume any responsibility or obligation to provide financial assistance or other assistance, including,

2. Insurance. I understand that WONDER&WANDER may elect to provide group accident or other liability insurance for the benefit of its volunteers. Any coverage so provided will be governed by the policy language. Except to the extent that it may provide such insurance, WONDER&WANDER does not carry or maintain any health, medical, disability, damage or other liability insurance coverage for the benefit of its volunteers, and expressly disclaims any responsibility or obligation to do so. IF I AM THE PARENT OR LEGAL GUARDIAN OF A YOUTH VOLUNTEER UNDER THE AGE OF 18, I UNDERSTAND THAT I AM EXPECTED AND ENCOURAGED BY WONDER&WANDER TO MAINTAIN MEDICAL HEALTH AND ALL OTHER APPLICABLE INSURANCE COVERAGE FOR MY OWN BENEFIT AND THE BENEFIT OF THE VOLUNTEER.

3. Medical Treatment. Except as otherwise agreed to by WONDER&WANDER in writing, I hereby release and forever discharge WONDER&WANDER from any and all liability claims, demands and causes of action whatsoever that may arise on account of any first aid or other medical treatment rendered during the participation of the Volunteer with WONDER&WANDER and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER.

4. Assumption of Risk. I understand that the participation of the Volunteer with WONDER&WANDER and/or any project, activity, or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER may include activities that may be hazardous to the Volunteer. I hereby expressly and specifically acknowledge that I assume the risk of injury or harm for the Volunteer in these activities and release WONDER&WANDER from all liability for injury, illness, death, and/or property damage that may result.

Photographic Waiver and Release.** I understand that while participating in project, activity, or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER, that WONDER&WANDER may film, photograph, or record the Volunteer's likeness or voice (the "Recorded Works"). I do hereby grant, assign, and convey unto WONDER&WANDER all right, title, and interest the Volunteer may hold in and to any Recorded Work made by or on behalf of WONDER&WANDER or made with its consent, during the participation of the Volunteer with WONDER&WANDER and/or any project, activity or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with WONDER&WANDER, including, but not limited to, any royalties, proceeds, or other benefits derived from such Recorded Works. I hereby agree not to sue and irrevocably and unconditionally release, waive, and forever discharge and hold harmless WONDER&WANDER and its successors and assigns from any and all liability, claims, demands and causes of action, of whatever kind or nature, either in law or equity, whether known or unknown, which I or the Volunteer, if different, ever had, now have, or may in the future have arising out of or related to the Recorded Works.

Other.** I expressly understand and agree that this Release is intended to be as broad and inclusive as permitted by law, and that the Release shall be governed by and interpreted in accordance with the laws of the State of Arizona. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.
