- 5. That Later I presented the said cheque With my bank, ICICI bank, branch Vikas Puri, Delhi. But the said check was dishonoured by my banker with the remarks "Account closed" while returning memo dated 12.01.2023.
- 6. That immediately I contacted you and disclose the fact about the dishonour of the said cheque and my client demanded the said cheque amount in cash from you, But since then you are passing the time by one pretext to another and now you instead of making the payment of the said cheque you have flatly refused to pay the said cheque amount to me in any manner and had also extended threats to face dire consequences.
- 7. That for discharging your liability you issued signed and delivered the above said cheque which was dishonoured by your bank as you have close your account. Thus you breached my trust & extended threats.
