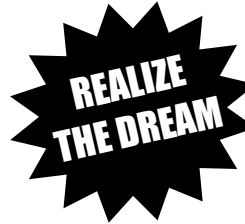

To promote, foster and encourage interest and support in the care, maintenance and development of multi-purpose equine and agricultural facility in Orange County, New York to encourage, promote and further interest in horses, equine sports, agricultural activities and events; to raise funds and solicit donations for interested individuals, charitable, educational and scientific organizations and foundations, and other interested organizations and foundations, agencies, institutions, associations and corporations and to administer and expend such funds in furtherance of the corporate goals and purposes; to hold, conduct and organize meetings, discussions and forums on all issues related to and involving horses and agriculture; to affiliate the corporation with other similarly constituted clubs, organizations, youth, equine and agricultural clubs and organizations, institutions, associations and corporations; to organize, sponsor and conduct social affairs, horse shows agricultural exhibitions and activities and excursions to such events and activities for the enjoyment of the membership; to disseminate information to the general public concerning such events and activities; to encourage the exchange of ideas and information on various topics and themes of interest to horse and agriculture enthusiasts; to aid, assist, cooperate, co-sponsor and otherwise engage in concerted action with private and governmental agencies and organizations on all programs designed, calculated and dedicated to further and advance equine and agricultural activities and generally to stimulate, encourage and promote public interest in equine sports, events and agricultural exhibitions by all available means and methods. The general powers enumerated in Section 202 of the Not-For-Profit Corporation Law, together with the power to solicit grants and contributions for the corporate purposes.
