WE HOSTED 27 #AMFGY6 WAR ROOM CALLS SERVING A TOTAL OF 158 VETERANS/FIRST RESPONDERS. THROUGH OUR GROUP SUPPORT ENCOUNTERS, AMF SERVED A TOTAL OF 135 VETERANS AND THEIR SIGNIFICANT OTHERS. WE SENT FOUR VETERANS TO LONG TERM TREATMENT CENTERS AND PROVIDED FINANCIAL ASSISTANCE TO 47 CASES.
