

**OFFICIAL TRANSCRIPT OF THE PROCEEDINGS OF THE GRANT VALLEY  
TOWN BOARD OF SUPERVISOR'S ANNUAL ROAD TOUR, MAY 18, 2019**

The Grant Valley Town Board of Supervisors met for their Annual Road Tour, which began on Saturday, May 18, at the Town Hall at 8:00 a.m. Those present for the tour were Supervisors Russ Hiltz, Noah Fuller, Nora Shanahan, Deputy Clerk Marlys Eckman, and Road Supervisor Keith Christianson.

**FERN LAKE ROAD:** Good, but needs gravel on area of ice heave.

**KIMMUR ROAD:** Needs stop sign at East end., plus Bump Sign needs repair.

**DORIS COURT:** Stop sign tipped, roads ok.

**RED OAKS ADDITION:** OK

**PINE CIRCLE COURT:** A few branches need trimming at entrance.

**BUCHANON:** OK

**SIXTEENTH STREET:** Needs Stop Sign at junction

**MONARCH:** OK

**COUNTRYSIDE ROAD:** OK

**LEONARDWAY RD:** OK

**SPORTSMAN'S ROAD:** OK

**TROPHY BUCK AND LITTLE DOE:** The West end needs some gravel

**MILLER ROAD:** Needs Class #5

**RIVER CROSSING:** The low area mid way needs some work, otherwise road looks good.

**RIVER HEIGHTS:** Still needs striping, and the loose gravel from winter placement needs to be swept off. Sign needs replacing. \* Semi Truck parking & the need for No Parking Signs, needs discussion at next Board Meeting.

**BELTRAMI LINE ROAD:** Yield Sign at intersection of Sunset Meadows needs replacing.

**SUNSET MEADOWS:** OK

**JADE DRIVE SW:** Private Road, but Developer may seek Township to take over. However.. Road in terrible condition.

**COUNTRY VIEW:** Brush from roadside cutting still in ditches, but Board hopes ~~to~~ anticipates the Spraying will take care of that.

**DEER HAVEEN CT SW:** Culvert by intersection still needs to be dug out and entire corner reshaped.

**HIDDEN MEADOWS:** Good

**TALL TIMBER LANE:** Good

**STONE LAKE ROAD SW:** Should have additional gravel out further along edges with shaping  
And sloping at the South end. Overall, Board felt recent blacktopping &  
Project turned out well.

**BOOTLEG LAKE ROAD SW:** Stop sign at intersection with Stone Lake Road needs replacing. Board  
should consider adding Class #5 gravel & make a cut on the north side.

**BOOTLEG LAKE ROAD SW:** One tree branch over the road needs cutting.

**TWAIN DRIVE:** Good

**DIVISION:** One T road sign down.

**WHISPERWOOD:** Good

**BALSAM RIDGE ROAD SW:** Looks good.

**MISTY MEADOWS:** Good

**SHAMROCK COURT:** Culvert needs repair

**LEPRECHAUN:** Good

**BLARNEY COURT:** Good

**SIRIUS POLLUX, CAPELLA:** Capella needs gravel filling on the sides & striping. Recent  
Blacktopping project looks good.

**GRANT LAKE LANAD:** Road Supervisor Christianson suggested he cut back area on west side of  
Intersection with Grantwood, to address water drainage issue.

**GRANTWOOD:** Good

**MELBY LANE:** Good

**STONE LAKE ROAD NW:** Needs Class #5

**STACYRICH:** Good

**BIRCH HILL:** Good

**OLD WILLOW COURT:** Good

**ARCHERY ROAD:** Good

**\*\* The Board decided to drive into Pine Tree Trailer Park due to past issues  
& found conditions to be deplorable. It was agreed that this issue should be  
Discussed at the next Board meeting with a desire to send a letter to the  
Beltrami County Environmental Department of their findings and  
actions needed.**

**QUIET POND & ARCHERY CLUB ROAD ENTRANCE:** The Locked gate recently damaged should be repaired or replaced with new.

**SCHROEDER ROAD:** Address sign is tipped

**QUINCY, KENNEDY and ADAMS:** Good

**HUMMINGBIRD:** Good

**JOHNSVILLE:** \*\* At next Board meeting, action should be taken for letters sent to property Owners at addresses 3561 & 3602 seeking permission to cut back bushes along township right of way.  
Tree trimming needed at Burlingame residence, #5330
