IMPORTANT NOTICE: BY SIGNING THIS AGREEMENT YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER ANY AND ALL DAMAGES IN CASE OF INJURY, DEATH, OR PROPERTY DAMAGE, ARISING OUT OF YOUR RIDING OR USE OF THE OWNER'S HORSE, OR ACTIVITIES OF OTHERS, OR ACTS OF OTHER ANIMALS ON THE PROPERTY, AND/OR PARTICIPATION IN EQUINE ACTIVITIES AT, **Springer Ridge Equestrian LLC**, INCLUDING INJURY, DEATH, OR PROPERTY DAMAGE ARISING OUT OF THE NEGLIGENCE OF YOURSELF, OR **Springer Ridge Equestrian LLC**

By signing this form, I hereby acknowledge on behalf of myself, and/or minors that I have legal or non-legal custody of, that I have familiarized myself with the activities that I will be allowed to participate in, and that I do hereby acknowledge and agree that I will participate in these activities without restriction or limitation. I recognize the inherent risks involved in riding and working with horses, including but not limited to: Bites, kicks, abrasions or contusions from horses. Being thrown or bucked off by horses. Scratches or other injury from stalls or enclosures. Scratches or other injury from grooming tools and other equine equipment and tack. Allergic reactions to animals, hay, or other environmental allergens. Tripping in holes or on materials or equipment.

Slipping, falling, or otherwise being injured in the barn, stalls, or on the grounds, which can be slippery, muddy, wet, or contain or present other hazards. Injuries caused from bites, stings, or allergic reaction to or caused by any and all animals including but not limited to ticks, mosquitos, dogs, rats, and horses. I hereby specifically forever waive and release **Springer Ridge Equestrian LLC** and its principals and agents from any and all liability for injury or damage arising out of the inherent risks from riding, working or participating in a stable environment and/or with horses, as well as from the active negligence of **Springer Ridge Equestrian LLC** its principals and agents.

COVID 19 disclosure. Under NO circumstances may an individual enter **Springer Ridge Equestrian LLC** if they or a direct household member are positive for COVID 19. Adherence to the CDC guidelines in accordance with the PA Dept. of Health shall be followed. By entering the property, you do so at your own risk. **Springer Ridge Equestrian LLC** is not responsible for individuals who may contract COVID 19 and other contagious diseases. I hereby specifically forever waive and release **Springer Ridge Equestrian LLC** and its principals and agents from any and all liability of health implications including hospitalization and or death due to COVID 19 and other contagious diseases.
