

Parental Consent and Waiver Form for Face-to-Face/Hybrid Classes



The Little Apprentice Preschool Inc. (TLA) has received approval from the Department of Education and Department of Health to conduct hybrid face-to-face classes (F2F). This affirms that our school is compliant with the minimum public health standards set by the government.

DURATION F2F will be held for the Summer of 2022 and School Year 2022-2023.

BENEFITS This present activity will address difficulties of learners in learning independently through pure distance learning and lack of access to technology and household resources. Moreover, our learners will benefit in the future from the information from this activity.

VOLUNTARY PARTICIPATION Participation in this F2F activity is voluntary. You or your child may decline to participate, or opt to withdraw from participation, at any time for any reason. If you or your child decide to withdraw participation after enrollment, you are required to inform the school as soon as possible by sending a formal Letter of Intent to withdraw.

The refund guidelines of the school will be strictly applied for those who will be withdrawing their participation.

EXCLUSION (LIMITATIONS/INELIGIBILITY) In accordance with the health and safety protocols, children with existing comorbidities should NOT participate in the implementation of limited F2F Learning Modality.

Children who test positive for COVID-19, or who have household members who test positive of COVID-19, shall follow the required quarantine period consistent with the latest national guidelines on returning to school. Students must be cleared by a licensed medical doctor before they are allowed back into the physical classroom. The same applies to children who may test positive while attending face-to-face classes.

Parents / guardians shall be asked to fill-in a health form at the beginning of each week before being permitted into the school to attend limited F2F. You are required to declare the health status of the student, and any other household member whom the student has close contact with. The health form will list a series of symptoms the child or household members may be experiencing related to COVID-19 such as, but not limited to, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, and diarrhea.

The health form must be filled-in with utmost honesty for the sake of your child and the other students, teachers, and staff of TLA.

RISKS, CONSENT AND WAIVER As the parent or legal guardian of _____, I hereby acknowledge that I have been informed of the details, rules, and guidelines of TLA in conducting limited F2F classes.

I understand that TLA shall implement the minimum public health standards set by the government to minimize risk of the spread of COVID-19, but it cannot guarantee that my child will not become infected with COVID-19, given that COVID-19 is highly contagious.

I understand that my child's in-person attendance in school will include associating with teachers, fellow learners and school personnel, and other persons inside and outside of the school that may put my child at risk of COVID-19 transmission, notwithstanding the precautions undertaken by the school.

I acknowledge that my child's participation in this activity is completely voluntary. While there remains the risk of possible COVID-19 transmission to my child, and to the members of my household, I freely assume the said risk and I permit my child to attend school.

I am aware that symptoms of COVID-19 include, but are not limited to, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, and diarrhea.

I will not allow my child to physically go to school to attend classes if he/she, or any member of my household develops any of the said symptoms or any other symptoms of illness that may or may not be related to COVID-19. I will also inform the school immediately and not allow my child to attend F2F if my child, or any of my household members, tests positive for COVID-19. My child and I, with my household members, will follow the required health and safety protocols and procedures adopted by the school and our community.

To the extent allowed by law and rules, I hereby agree to waive, release, and discharge any and all claims, causes of action, damages, and rights against the school and its personnel as well as officials and personnel of the Department of Education.
