## OLD BUSINESS

1. Mailing list update: President requested new members and current members (whose contact information has changed) to email him with contact information.
2. Archives: Phillip Lowe gave an update of the TCCBDA History and Archives project. Requested help with gathering programs and recordings from previous TCCBDA All-State Concerts dating from 1974-present.
3. Check website: President informed members present that the TCCBDA website ([www.tccbda.org](http://www.tccbda.org)) is the official source of all information regarding the All State process. He recommended that members check the site regularly for updates.
4. Rotation of Concerts at TMEA: President updated with latest information. Proposed a rotation of the concert order with the choir. It was reported that Jim Lee, executive director of the Community College All-State Choir, has verbally agreed to the proposed rotation. A resolution to the situation is being actively sought with TMEA by the president.

5. Clinicians: Steve Weist has given his verbal confirmation as clinician for the All-State Jazz Band (contract submission is pending) and John Whitwell has given his verbal confirmation as clinician for the All-State Symphonic Band (contract submission is pending).

## NEW BUSINESS

1. [Proposed: Reimburse Symphonic Band Organizer the cost of copying and postage when sending out the required All-State Symphonic Band seating audition music from TCCBDA funds, if needed, invoiced to TCCBDA not to exceed \\$500.](#)
  - Richard Birks moved to accept proposal
  - Seconded by Phillip Lowe
  - Approved by membership
    - a. It was also recommended that the Symphonic Band Music Organizer scan and email Chair Audition Music to schools instead of copying and sending it through the mail. This will save time in getting the music and money.
2. Increase Participation in All State Process: The president outlined a plan to increase participation in the All State process including, but not limited to:
  - a) Sending letters out to all Texas community college presidents and directors of community college bands.
  - b) Member networking.
  - c) Plea for more participation in Jazz All-State auditions.
3. Change in TMEA All State Student Registration and fee payment procedure: TMEA has asked for students to register for and pay TMEA fees online. President led an informal discussion with members present. Several questions were raised. President stated that he would investigate the ramifications of the request (especially the mechanics of retrieving student badges from TMEA). No formal action taken.

5. Selection of All State cuts by committee: All cuts selected and submitted to vice president and will be posted to the website
