Bathgate Community Council is responding to your email of the 8th June 2021 on the subject of the Common Good Register for Bathgate.

We believe that the property on your current list as circulated is in all likelihood common good land from the old burgh.

We wish however to suggest other property in the Bathgate ward that may also be common good land. They are as follows

Limefield Public Park and adjacent spare ground

Public Park at top of Marchwood Cres.

Open Space adjacent to Bruce Road

Former Travellers site at Sibbalds Brae

Land opposite Tesco on Blackburn Road/Leyland Road

Land and Path to the south of Tesco Store

Playing Field at Marina Avenue

Park and Land at Alexandra Drive

Land behind the former War Memorial Wallace Road

Open Space land between Whitburn Road and Meadow Park bound by the bog burn Land and Woodland to the south of Morrisons Store bound by the Railway line and the Boghead Burn.

Woodland and Land including the SUDs Ponds Wester Inch

Land on which the Bathgate Parish Church stands at Edinburgh Road opposite Kirkton Park

We do believe there may be other parcels of land that may fall into the category of common good land so we will continue our research and discussion with the community and reserve the right to suggest additions to the register.

We also would like to suggest that any artifacts or goods /furniture from the Burgh Councils era should be identified and held as part of a Bathgate Common Good Fund if they are still in existence.

We wish also at this time to raise the issue of the management and use of this land that ends up included in the register of Common Good Property in future. We believe that the Bathgate Community Council should be responsible for the consultation with the community on the use or proposed change of use of any land on the register. The Scheme for Community Councils gives us a right and responsibility to represent the views of the community to the West

Lothian Council. We also believe any revenue or capital gained from the use or sale of any registered land should be administered by the Bathgate Community Council in a common good fund.

We look forward with interest to developments on this subject
