Minutes of the Regular Board Meeting of the
Village of Southern View Board

CALL TO ORDER: The President and the Board of Trustees held the regular scheduled meeting on Tuesday, April 27, 2021 at the Southern View Municipal Building, 3410 South Fifth Street, Southern View, Illinois via Zoom. The meeting was called to order at 6:00 pm by President Patsche, followed by Roll call and the Pledge of Allegiance.

PUBLIC COMMENTS: Chris would like a follow up on the west side of the park a walkway over the drainage ditch. President Patsche stated that unfortunately Trustee McLaughlin is not here tonight and we can add this to the agenda next month for discussion.

NEW BUSINESS DISCUSSION: President Patsche presented a request for a Special Event Permit for Outside Sale of Liquor at Sunset Inn May 12th and June 12 of 2021.

MOTION PASSES.

President Patsche presented hiring of 2 part time officers and send the officers to basic training. The Village will receive reimbursements of the fee once the officers complete the training program. Class is from June through December of 2021. Unfortunately, we are having a difficult time finding certified part time police officers.

MOTION PASSES.

President Patsche presented Ordinance 21-04-01 An Ordinance Revising Fines for Improper Parking in the Village of Southern View, Illinois. Trustee Pierce stated this has come to our attention on parking issues where no parking is posted on 2nd Street. The current fine is \$3.00. Ordinance 21-04-01 will increase the fine to \$25.00 within 5 days and \$50.00 after 5 days. After a long discussion, resident Todd Taylor, who works with the Springfield Fire Department as an Inspector and Code Enforcement offered to assist the Village on the required width of roads needed for emergency vehicles before any no parking areas being designated.

President Patsche presented the Straight Street Drainage Plans that Kuhn & Trello has approved. President Patsche is asking for approval for Kuhn & Trello to put the project out for bids. At next months meeting Kevin Kuhn will bring the bids for the project to the board for approval.

MOTION PASSES.

Trustee Pierce stated they have replaced 6 stools in the Southern View Park. Moving the water heater from the East Pavilion to the Martin Pavilion and will install a 6 gallon water heater in the East Pavilion. Public Works have cleaned out the south ditch of the park, mulched the playground and around some trees in the Park. Public Works will start on the West end of the Village and go East on culverts and ditches shortly. Trustee Pierce would like to purchase a laser light kit between \$600 - \$750. It will save a lot of time and money having a laser to dig out the ditches. Trustee Pierce stated he is calling around to obtain bids to stripe the village streets with some sort of retroreflectivity in the paint.

Trustee Bourland stated he had 2 building permits for the month, a front awning and a 24 x 24 garage and approach on Rita.

Trustee Eskew stated some letters have went out and he has stopped by a home today to remind them that the pickup is not until May 17th and they would need to move the items out front until the weekend before the pickup. Trustee Eskew stated he would like to put a welcome packet together for new residents to inform them of our ordinances.

Trustee Haines stated UHaul is moving along.

Chief of Police reported the Police Department has received the body cameras and will be in contact with WatchGuard to install and deploy the body cameras hopefully by mid-May of 2021. The Officers are doing a great job and have gone over and above.

Kevin Kuhn with Kuhn & Trello reported they will be evaluating the roads in the Village to determine which roads will need the attention this year.

No other reports were given.

ADJOURNMENT: With no further business, President Patsche asked for a motion to close the meeting at 6:13pm. Motion was made by Trustee Bourland and 2nd by Trustee Eskew.
