The President and the Board of Trustees held the regular scheduled meeting on CALL TO ORDER:

by President Patsche, followed by Roll call and the Pledge of Allegiance.

NEW BUSINESS DISCUSSION: President Patsche asked for discussion and approval of hiring summer help for the Public Works Department.
