Minutes of the Regular Board Meeting of the Village of Southern View Board

CALL TO ORDER:

The President and the Board of Trustees held the regular scheduled meeting on

Tuesday, June 22, 2021 at the Southern View Municipal Building, 3410

South Fifth Street, Southern View, Illinois. The meeting was called to order at 6:00 pm by President Patsche, followed by Roll call and the Pledge of Allegiance.

APPROVAL OF THE MINUTES: President Patsche asked whether the Board had reviewed the May 25, 2021 Minutes and if they found need for any changes, corrections, or amendments. President Patsche said after hearing none, the May 25, 2021 minutes stand approved as submitted.

**SWEARING IN OF NEW TRUSTEES:** President Patsche asked for Greg Bourland to recite the oath of office for the positions of Trustee of the Village of Southern View Board.

**APPROVAL TO PAY BILLS:** President Patsche asked whether the board had reviewed the June 22, 2021 Bills to be Paid, and whether there were any changes, corrections, or amendments. Trustee Eskew asked if all of the electrical work had been done in the Public Works Bldg. President Patsche stated only in the 3<sup>rd</sup> bay of the building.

President Patsche asked for a motion to approve the bills as modified. Motion to Approve the Bills to be Paid as presented by Trustee Eskew and  $2^{nd}$  by Trustee Bourland. Upon roll call vote, all voted AYE **MOTION PASSES.** 

**APPROVAL OF THE TREASURER REPORTS:** President Patsche asked whether the Board had reviewed the May 2021 Treasurer Report and if they found need for any changes, corrections, or amendments.

President Patsche said hearing none, the May 2021 Treasurer Report Stand approved as submitted. Motion to approve the May 2021 Treasurer Report as presented by: Trustee Eskew and 2<sup>nd</sup> by Trustee Pierce

Upon roll call vote, all voted AYE, except for Trustee Bourland voted present. **MOTION PASSES.** 

**PUBLIC COMMENTS:** Andy Golman, Sangamon County Auditor, reported his job is to audit the financials of Sangamon County, budget and review all the bills. Andy stated he is proud of the fact they have a balanced budget. The Sangamon County budget is 121.5 million dollars. In 1994 Sangamon County had 810 employees and now they have 684 employees, due mainly to technology. Sangamon County has received 18.9 million this month from the federal government and will receive an additional 18.9 million next fiscal year. In November of 2021, Sangamon County will be remodeling. Once remodeling is done the entrance to the County building will be on Adams Street. Sangamon County's building was built in 1991 and is needing some upgrades and part of that is installing new elevators.

Trustee LaRussa left the meeting.

Don Gray, Sangamon County Clerk, reported some changes within the Election process. The primary election has been moved from March to June 28. Clerk Gray and his office are looking forward to seeing how moving the election to warmer weather effects the turnout. January 13 is the day they will start circulating paperwork for offices, March 7<sup>th</sup> to the 14<sup>th</sup> will be the week of the filing period, May 12<sup>th</sup> will be when ballots for mail in voting will be mailed out with May 19<sup>th</sup> beginning of casting of ballots in early voting. Don Gray thanked the Village for providing the Village Hall for the polling location. It has worked out well the last two elections. Illinois has passed a permanent vote by mail. Last election shows 1/3 of

voters cast their ballots by mail. Don Gray thanked the Police Department for their service and will be stopping by this fall to purchase lunch for the Police Department.

Kathy Allen, resident of the Village, asked if we are going to have a picnic and a fall garage sale and pickup. President Patsche stated we had not talked about that yet, he would like to have some sort of picnic. Garage Sales are any time. The Public Works department picked up over 85 tons of junk this Spring with only 285 houses utilizing this service, within 10 days.

Brad Miller, Woodside Township, thanked the Village for providing Cody Bounds from Public Works and one of the Village's trucks for 2 ½ days picking up the junk pick up in Laketown.

Don Craven introduced his son, Joe Craven, attorney, who has joined his firm in June of 2021. He will be attending the meetings with Don to learn the business.

POLICE PRESENTATION: Chief Wiese addressed the Board and the public to present awards to Sergeant DeWitt. The Police Department has received a letter from AAIM, Alliance of Intoxicated Motorist along with several awards. Sergeant DeWitt was presented with a certificate and pin for 10 DUIs. Sergeant DeWitt also received a certificate and pin for 25 DUIs. Sergeant DeWitt also received a certificate, pin, sticker and patch for 50 DUIs and another set for 100 DUIs. Sergeant DeWitt conducted his 158<sup>th</sup> DUI on his last shift. Chief Wiese stated Sergeant DeWitt is an asset to his team as he takes on a lot of responsibilities within the department and is responsible for scheduling the officers.

**NEW BUSINESS DISCUSSION:** President Patsche presented Ordinance 21-06-01 An Ordinance Making the Appropriation for Expenses of the Village of Southern View, Illinois for the Fiscal Year Ending May 31, 2022.

President Patsche asked for discussion and approval the opening of renting the pavilions in the park and the renting of the municipal building. President Patsche stated that the bathrooms are open in the park. Trustee Pierce stated the stools have been replaced and they will be adding water fountains to the Martin and West pavilion.

Motion to approve opening the park and municipal building for rentals starting July 1<sup>st</sup>, 2021 as presented by Trustee Bourland and 2<sup>nd</sup> by Trustee Pierce Upon roll call vote, all voted AYE **MOTION PASSES.** 

President Patsche asked for discussion and approval of the non resident rate of the Village Hall. Clerk Cave stated 80% of the phone calls for rental of the building is from non residents.

Motion to approve raising the non residential rate of the Village hall rentals to \$500.00 with a \$250.00 cleaning deposit for rentals starting July  $1^{st}$ , 2021 as presented by Trustee Bourland and  $2^{nd}$  by Trustee Eskew Upon roll call vote, all voted AYE **MOTION PASSES.** 

President Patsche addressed the Board that we have received requests from the military to waive the rental fee of the municipal building and an email from Val Ramey in regards to Walk for Wishes scheduled in October 2021 has also asked for a waiver of the rental fee at the park. After discussion, the Board felt that any type of requests needs to be brought before the board for consideration for any waiving of rental fees in the future.

Motion to approve waiving the rental fee of the hall to the military and waive the park rental fee to Val Ramey, Walk for Wishes as presented by Trustee Eskew and 2<sup>nd</sup> by Trustee Bourland Upon roll call vote, all voted AYE **MOTION PASSES.** 

President Patsche introduced Phil Webber, Kuhn & Trello, to explain the two grants the Village can apply for. There is a RAISE grant and a Covid Relief Grant. The RAISE grant, the Village would be in the rural category and it is for a total of one million dollars with 20% coming from the Village although the Village can apply for a waiver of that contribution, deadline is July 12, 2021. Engineering costs for the RAISE grant is \$4,000. The Covid Relief Grant is also one million dollars with 100% covered, with zero contribution from the Village. The Village would fall into the urban category and the deadline for this grant is also July 12, 2021. The Village can apply for 3 applications for the Covid Relief Grant. November 22, 2021 they will announce who receives the grants.
