The meeting was called to order at 6:00 pm by President Patsche, followed by Roll call and the Pledge of Allegiance.

NEW BUSINESS DISCUSSION: President Patsche presented the reappointments and appointment of zoning board members. President Patsche suggested we repair this as soon as we can as Trustee Pierce is meeting next week with another contractor. President Patsche would like a not to exceed \$5,000 to repair the roof leak.
