
REAL ESTATE & PERSONAL PROPERTY TAX RELEASE NOTES – DECEMBER 2015




1. MAINTENANCE

Prior to the software update, the lookups for Parcel Master by Location and Parcel Master by Street were the same. This was corrected to allow users to search for parcels more efficiently.







1.1.2. Post Billing & Work In Progress

There was an issue with the PP and RE billing posting that created suspense transactions shown on the posting report. This was corrected and patched to sites and is included here to document the change.

2. SCHEDULED TASKS FEATURE

A new feature has been added to the way the billing process steps work. Now sites may choose to run the **Calculate Taxes, Generate Bills** and **Generate Export Files** as a scheduled task instead of interactively. The



advantage to using this is that it will allow the person running the task to step away from the computer or perform other tasks while the processing is performed.



If a command window appears when the scheduled task begins then just minimize it. DO NOT close it.

To implement this, the values of module control should be set to **"Y"**. These options are available for both Real Estate and Personal Property Billing. Contact <u>support@admins.com</u> for assistance in using this new feature.


Figure 5 New Module Control Settings
