This document explains new product enhancements added to the ADMINS Unified Community for Windows REVENUE COLLECTIONS system.

1. BILL DETAIL SCREEN NOW INDICATES QUARTER

The bill detail screen for Personal Property and Real Estate bills now indicates the quarter for the bill date. This is not available on Motor Vehicle Excise bills, as the Quarter is not relevant to those bills.
