## Statement of Religious Exemption From Mandatory Vaccination

### To Whom It Concerns,

WHEREAS ***Bible Believers Fellowship*** holds the Holy Bible (King James Version in English) as our full and final authority on all matters of faith and practice; and

WHEREAS the Holy Bible teaches that our body is the "temple of the Holy Ghost" (1 Corinthians 6:19); and

WHEREAS each of us shall be held accountable to God for what we put into (or allow to be put into) our bodies (Romans 14:12); and

WHEREAS, it is stated in our official statement of faith, that "God alone is Lord of the conscience," and that, "The state owes to every church protection and full freedom in the pursuit of its spiritual ends." And that, "Civil government being ordained of God, it is the duty of Christians to render loyal obedience thereto in all things not contrary to the revealed will of God," but that when such government requires obedience that IS contrary to the revealed will of God we must heed the divinely inspired commandment given in Acts 5:29, "Then Peter and the other apostles answered and said, We ought to obey God rather than men."; and

WHEREAS we respect The U.S. Constitution and Bill of Rights as ordained of God (Romans 13:1-5) wherein the First Amendment guarantees that, "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; and

WHEREAS Title VII of the Civil Rights Act further guarantees that public and private companies with 15 or more employees provide religious accommodation to employees with sincerely held beliefs; and
