MINUTES FROM THE ANNUAL MEETING - November 22, 2019 - Bismarck Veterans Memorial Library

Board Meeting: Started at 4:10 pm.

Attended: Leon Glasser, President, Directors – John Bubel, Doug Plummer, Sharlene Reuer, Sally Dasinger, Administrator.

Minutes from the November 10, 2018 were provided. Doug Plummer moved to accept the minutes as written and John Bubel seconded. All accepted.

Treasurers report for 2019 was provided by the administrator. Doug Plummer moved to accept the minutes as written and John Bubel seconded. All accepted.

2020 Stallion Auction: at the time of the meeting there were 21 stallions donated. Advertising was discussed. It was suggested to advertise in the Speedhorse and Racing Magazine along with a Barrel racing magazine to attract barrel racers.

NDQHRA Races: Track conditions were discussed, issues included were the track be watered more evenly.

No one volunteered to be on the NDQHRA board. Suggested to move the meeting a bit earlier in the year to possibly get more attendance. The terms are up for the President & Vice President and election for both will be held in the General Meeting.

Other Business: Grant Vander Vorst sent a request to the board to have the NDQHRA participate in a SD preferred race in Canterbury Park. The board felt it was not beneficial to the NDQHRA, so it was decided not to participate.

It was decided to provide a "Blacklist" of those who have not paid the NDQHRA for commitments such as NSF checks or winning bidders in the annual stallion auction, who do not pay. Anyone on this list is not allowed to participate in the NDQHRA or it's races. The newsletter will contain a list and if someone wants their name removed, they must provide restitution. It was moved by Doug Plummer to do this and seconded by Sharlene Reuer. The rest approved by roll call.

It was decided to enforce a 15-day payment deadline for the stallion auction. If it is not paid by the end of 15 days, it will automatically be returned to the list of stallions for sale.

John Bubel moved to adjourn the meeting. It was seconded by Sharlene Reuer. All approved.

General Meeting: Started at 5:00 PM

All were present from the board meeting and no new members arrived, so it was agreed to skip to the election. John Bubel nominated both Leon Glasser and Randy Schwartz to continue in their current positions of President and Vice President. Doug Plummer seconded it and all accepted.

The Free Birth drawing was held with John Bubel winning. John Bubel moved to adjourn the meeting and Sharlene Reuer seconded. All agreed.

\$23,500 Estimated purse to be run: Sunday, August 16, 2020 at Canterbury Park.

FOR QUARTER HORSES, TWO YEARS OLD WHICH ARE NORTH DAKOTA BRED OR SOUTH DAKOTA BRED.

\$150 to nominate by Friday, May 15. \$250 sustaining payment due by Monday, June 15. \$350 sustaining payment due by Wednesday, July 15. Late payments will be doubled or all eligibility will be forfeited. All nominations and payments must be made through the NDQHRA or SDQHRA. \$50 to enter, \$50 additional to start. \$23,500 Estimated (Includes \$3,000 from NDQHRA) (Includes \$3,000 from SDQHRA) of which 42% to the owner of the winner, 17% to second, 10% to third, 7% to fourth, 6% to fifth, 5% to sixth, 4% to seventh and 3% to eighth, ninth and tenth. Weight: 124 lbs.

The 1889 Futurity will be limited to ten (10) starters. Total earnings in 2020 will be used in determining the order of preference of horses, consisting of the top 5 North Dakota bred leading money earners and top 5 South Dakota bred leading money earners. If either state does not have enough horses to fulfill their allotment, the other state will have preference to enter additional horses. Reminder: All memberships through the NDQHRA or SDQHRA must be current. A trophy will be presented to the winning owner. The final purse will be reduced by the cost of any Out of Competition testing required by the Minnesota Racing Commission as a condition of competing in this race.
