Changes at Yucaipa City Hall

As you may be aware, Yucaipa has a new City Manager, **Chris Mann**. Not everyone in Yucaipa is happy with the changes, but it's a done deal and we need to move on. Mann will be our guest speaker at an upcoming YMRA meeting in July and will update us on his vision and plans for the mobilehome park community in Yucaipa. Two new positions have been approved for City Hall staff with some re-organization of responsibilities among existing positions. These changes will probably not be obvious to most people in Yucaipa, but one directly affects mobilehome park residents. **Kim Metzler** has a new title and new responsibilities: Deputy City Clerk/Deputy Rent Administrator. She will be able to focus more on the Mobilehome Rent Stabilization Program while backing up City Clerk functions as needed. Hopefully this means she will have more time to devote to relationships between City Hall and park residents and to help improve our quality of life in Yucaipa.

Membership Matters

This gives us the right to say that we represent our large mobilehome park community, the only local organization that supports, advocates for and gives a united voice to mobilehome park residents. New California Legislation Introduced in 2023

About 2,600 bills have been introduced in the California State Legislature for the 2023 session. More than 1,000 are "placeholder" bills without specific language to leave room for additional bills which might be proposed. Bills of specific interest to mobilehome park residents include:

- **AB 1035 Mobilehome Parks: Rent Caps** (Muratsuchi): This bill would prohibit the management of a mobilehome park from increasing the gross rental rate for a tenancy for a mobilehome space more than 3 percent plus the percentage change in the cost of living, or 5 percent, whichever is lower, of the lowest gross rental rate charged for the tenancy at any time during the 12 months prior to the effective date of the increase.
- AB 604 Mobilehome Parks: Water Utility Charges (Lee): This bill would provide that the limitations on charges and fees in connection with water utility service apply to all management that elects to separately bill water utility service to homeowners.
- AB 318 Mobilehome Residency Law (MRL) Protection Act (Addis): This bill proposes to eliminate the 5-year sunset on the Mobilehome Residency Law Act (AG 3066), which amended the Health and Safety Code to establish the Mobilehome Residency Law Protection Program (MRLPP), a five-year pilot program housed within the HCD to help coordinate the resolution of complaints from homeowners relating to the Mobilehome Residency Law (MRL). The Act requires HCD to select the most severe, deleterious, materially, and economically impacted alleged violations of the MRL for state evaluation, including any alleged violations that may lead to eviction. When enacted, this law was intended to protect and safeguard the most vulnerable mobilehome homeowners by affording them an additional avenue to enforce violations of the MRL.
- **AB 22 Mobilehomes: mobile coaches** (Gipson): This bill would express the intent of the Legislature to enact legislation that would classify motor coaches that are parked in a mobilehome park for a period of time that satisfies residency requirements as mobilehome properties to give mobile coach owners the ability to build home equity. The bill would state findings and declarations in that regard.

Scherer Community Center

The Scherer Community Center is open again and providing services and nutritional programs for Yucaipa seniors. The Center acts as a referral agency to assist seniors with legal, medical, and financial issues and as a Cooling and Heating Center during operating hours throughout the year. Located at 12202 First Street (between Ave A and Ave B), the Center is open Monday-Thursday, 8:30 a.m. To 4 p.m. Activities and social programs include:

- Exercise and fitness Aerobics, Chair Aerobics, Gentle Moves, Japanese Dance, Line Dancing, Tai Chi
- Activities Billiards, Cards R Us, Chess and Checkers Club, Craft n' Creations, Knit and Crochet Club, Senior Paint and Art Club, Senior Ping Pong Club, Ukulele Club
- Nutrition Services:
 - Family Services Association provides nutritious meals to seniors who must be at least 60 years young. Hot meals are available next to the Scherer Community Center from 11:30 a.m. To 12:p.m.; check-in begins at 10:45 a.m. A suggested donation of \$3.00 a person would be greatly appreciated.
 - "More Than a Meal" program delivers meals to home-bound seniors. To sign-up for the homebound meal program, call FSA at (909) 790-3170.
 - USDA (Commodities) Yucaipa Christ Redeemer Church is offering the monthly USDA Commodity distribution program previously provided through the City of Yucaipa. Monthly food packages are distributed via a drive-thru at the church, located at 12148 4th Street, on the 3rd Wednesday of the month, from 1 p.m. To 3 p.m. Participants must be low-income and the person picking up must be at least 18 years old.
- "Golden Wheels" Program Yucaipa is finally about to "roll out" its new transportation service for seniors and disabled persons. Yucaipa City website states it is to begin in Spring 2023. When I get a definite date, I'll let you know. Transportation will be provided daily (excluding holidays) Monday - Friday, between 8:30 a.m. and 4:00 p.m. Transportation will include basic needs such as grocery shopping, pharmacy visits, and additional personal needs within City limits. Travel within City limits will be free; there will be a low cost to seniors traveling on proposed excursions to be offered by the City of Yucaipa Community Services Department.
