## **Help with Soaring Heating Bills**

If you are unable to attend the meeting on February 11, here is the information to help you apply for assistance with your energy bills.

- **CARE**, So Cal Gas: Call 1-800-427-2200 or visit website <a href="www.socalgas.com">www.socalgas.com</a> Click on "Save Money & Energy" then "Assistance Programs". Maximum household Yearly income for 1-2 people \$36,620. They have a 20% monthly discount available or a one-time bill grant. Also a Past Due Bill Forgiveness plan if you qualify.
- **FERA** Southern Calif. Edison: Maximum Yearly income same as CARE. Contact So Cal Edison at 1-800-655-4555
- **HEAP** Electric, Gas, Water, assistance. Maximum monthly income 1-2 people \$3,353.87. For an application packet you can call (909) 723-1500 or email <u>utilityassistance@capsbc.org</u>.
- SoCalGas Assistance Program One time grant up to \$100. Maximum Yearly household income 1-2 people \$36,620. Call 1-877-238-0092. Not available for sum-metered billing; bill must be in name of applicant, not the park you live in. You must be required to pay SoCal Gas directly, not on your rent bill to the park.

SoCal Gas did say in recent news releases that natural gas prices will be coming down in February, but apply now for assistance in coming months. According to our friendly groundhog, Punxsutawney Phil, we can expect six more weeks of winter.

## **Membership Matters**

YMRA membership is important to the mobilehome park residents community. We need your involvement and attendance at our meetings. YMRA serves a community of over 4,200 mobilehome spaces in the city of Yucaipa and is devoted to advocating for mobilehome residents throughout the area. Your membership and attendance gives us the right to say that we represent our large mobilehome park community, the only local organization that supports, advocates for and gives a united voice to mobilehome park residents. ## **Building Permit Requirements for Mobilehomes**

It may not be widely known, but modifications and/or structural improvements to mobilehomes require a building permit which must be issued by the California Department of Housing and Community Development (HCD). This requirement applies to manufactured homes, mobilehomes, multifamly manufactured homes, and commercial modulars. City and county requirements for building permits do not apply to mobilehomes. Permits must be requested by the mobilehome owner or someone contracted to do the work whether the home is owned by the mobilehome park or by the resident. **HCD** has sole authority for permit issuance and inspections of alterations, conversions, or the change of use of units, or to conduct inspections to obtain insignia of approval.

Examples of alterations, additions, etc., to mobilehomes which require permitting include, but are not limited to:

- Installation or replacement of air conditioning or evaporative cooling units
- Installation or replacement of electrical units such as ceiling fans, changes to electrical systems, electrical panel or circuit
- Installation or replacement of furnace, heat pump, or heating stove
- Installation or replacement of built-in oven, range, cooktop or freestanding range, range hood, water heater
- Install/modify drain, wast, and vent, or water system, natural gas lines
- Install (add) garbage disposal
- Structural modifications to chassis or frame; replace exterior doors or windows; repair any structural
  component such as joists, rafters, roof, interior walls, exterior or interior wall covering; attach awning
  for garage or porch

#### How to File a MRL Complaint:

We constantly get requests for information on how to file a complaint pursuant to the Mobilehome Residency Law Protection Program administered by California Department of Housing and Community Development (HCD). This program offers help for mobilehome/manufactured homeowners to resolve complaints for certain violations. Here are some FAQs to assist you:

- Who can submit a complaint? Any mobilehome/manufactured homeowner who lives in a mobilehome park. It is often beneficial if more than one homeowner in the park signs on to the filing.
- What types of complaints can be submitted? Any complaints for issues within mobilehome parks related to Mobilehome Residency Law (MRL) violations. Common violations include illegal grounds for eviction, failure to provide proper notice of rent increases, failure to maintain common areas, or no written rental agreement between the park and mobilehome owner.
- How does a mobilehome/manufactured homeowner submit their complaint? Complaints must be submitted to HCD who will provide help to resolve and coordinate resolutions of the most severe alleged violations of the MRL.
