Year in Review

- Arranged and sponsored 2 Managing Your Mood groups and 2 Pandemic Parenting groups
- Held 9 Screening and 5 Steering Committee meetings (4 regular and one vote meeting)
- Held 2 Coordinator's meetings with the Coordinators of the other START model programs
- Uploaded all START information to the Risk-Tracking Database and continually update
- Participated in the review of Community Mobilization initiatives by the University of Manitoba
- ▶ Hired an additional Coordinator

Year in Review

- Presentations were made to: Standing Committee of CFS on the START model and Community Mobilization programs in Manitoba on Shared Measurement
- Represented START on the Interlake Service Providers, the Interlake Sexual Exploitation Educators (ISEE), Serious Habitual Offenders Comprehensive Action Plan (SHOCAP), Youth HUB, Brokenhead Ojibway Nation Service Providers and the Do it Better, Do it Safer Committees.
- Staff attended training in harm reduction, pandemic parenting, compassion fatigue, high risk substance use, sexual exploitation, VTRA (Violent Threat Risk Assessment) and restorative justice
- Received grants from the Selkirk Community Renewal Corporation and the Canada Emergency Response Fund
- Case conferences: 408 Total (259 Youth, 149 Re-START)

A Decolonizing Approach

- Indigenous history courses have now been completed by START Program Manager and Coordinators
- Indigenous supports are to be included on teams for Indigenous clients unless they choose otherwise and statistics are kept to track this.

Inclusion of Families and Survivors

- START sees family through the eyes of our clients and includes their definition of family, no matter how broad that may be.
- START has always included our clients and families as the central part of the team.

Reconciliation

Self-Determined and Indigenous-Led Solutions • and Services

- START entered into a Memorandum of Understanding with Brokenhead Ojibway Nation to work collaboratively between the two organizations, including adding a seat on our governance board for BON.
- START is also a supporting agency for Peguis First Nation's Youth Hub in Selkirk.





Schools attended (START Youth)







Outcomes for START (Youth)

Improved living situation 85%

Increased understanding of youth's challenges 95%

Accessed Services not previously utilized 87%

Created a successful safety plan 100%

Improved attendance/partici pation in school 82%

Attained a better knowledge of atrisk activities

Outcomes for Re-START

Reducing the Burden on the Justice System

- 76% of clients decreased or held on their number of charges compared to the year prior to involvement
- 74% decrease in the number of calls to police

Enhancing Employability

- 18% of clients became employed
- 26% of clients have returned to high school or trade school

Reducing Risk Factors and Barriers to Success

- 68% of clients with problematic substance use that are now receiving counselling/practicing harm reduction or have reduced their use
- 85% of clients experiencing homelessness have acquired housing with Re-START's assistance
- 88% of clients now been connected to new services

Goals for the upcoming year

- Continued creation and set up of our new programming
- Start drawing statistics from the RTD
- Create system of measuring success for short-term consults
- Determine how to measure effect of our programming on health care needs such as emergency room visits and ambulance usage
- Continue working towards the Calls to Action for the Truth and Reconciliation Commission and Missing and Murdered Indigenous Women and Girls reports
