- **I. Welcome**: Stewart Tabb called the meeting to order at 7pm. Susan Meredith led the opening devotion.
- **II. Check in**: Do you have a Bible verse you turn to again and again? What is it and why? If not a Bible verse a prayer. Discussion followed with favorite verses and Bible passages.

III. Committee Reports:

- 1. Finance Budget for February was discussed.
 - a. Expenses for February increased by \$7000. Additional research will be done to determine cause of overage.
 - b. R&M expenses doubled over projection.
 - c. Pledges exceeded monthly projection.
 - d. Pledge Calls Updates given.
 - e. Doug Thompson will train people for Audit.
- 2. DCDI Report Kris Huddle provided update. Total of 45 responses received out of 65 active members. Forty-three responses from survey monkey and two paper responses. DCDI team will continue to work with survey responses and adding functions for relationship building,

V. Clergy Report: Stewart Tabb present.

- 1. Day School Director Mark Hattler has resigned due to health issues. Assistant director, Jennifer Wilson, is moving into the interim director's position. The board will review this position in 2 months to determine if any changes are needed. Jordie DiFernando is moving to the school in full time position.
- 2. Parish Administrator Jordie will vet & train Parish Administrator replacement. Reduction in position hours to 12 hours.
- 3. Revision of Diaconal Agreement a new agreement was proposed to pay a smaller about to our deacon Genevieve Nelson, which will allow her access to the clergy wellness programs sponsored by the Church Pension Fund.
 - a. Past agreement \$1200 discretionary. \$6000 professional expense
 - b. New agreement \$600 Discretionary fund. \$100/ a month (\$1200/year) (\$18/month or \$216/year pension) +7.65/month or 91.20/year Social security with \$5000 professional expenses. Net cost is the same as past agreement.
- 4. A motion was made to accept the Revised Diaconal Agreement. The motion was seconded and unanimously approved. Holy Hike Botanical Garden on April 1st.

VI. Schedule/Devotions: Susan Meredith led the closing devotions. The next regular Vestry Meeting is scheduled for Tuesday April 18, 2023 @ 7 PM. Rick Jones to lead the devotions at this meeting.
