James McCabe Director, Child Protection Unit

James spent 20 years in law enforcement at State, National and International level. James is a qualified Prosecutor and Senior Detective and oversees all investigations and operations of the CPU.

James returned to Cambodia in 2012, where he created the concept of the CPU and with Scott Nesson's guidance and support made it a reality. James has been investigating and coordinating investigations into crimes against children since 2012.

Crimes including homicide, sexual assault, child trafficking, internet-based crimes and all forms of serious abuse require a specialized and coordinated response from investigative and support agencies. In the past 10 years the Child Protection Unit has proven time and time again the effectiveness of a collaborative process. The initial concept of a partnership between former international police, experienced in modern investigative procedures, and the most promising Cambodian National Police has produced remarkable results.

Whether measured in terms of arrest rates, prosecution rates, the introduction of forensic evidence, police training or the after-care provided to child victims, the CPU has surpassed all expectations.

"There is no greater responsibility or honour then protecting those that cannot protect themselves - children".







### Safeguarding & Child Protection in Education Symposium Synopsis

### Train the Trainer courses - 10th August

### Group A - Level 1 Safeguarding Trainer Certification

Aim : To provide participants with an indepth understanding of what needs to be taught in the Level 1 Safeguarding training and provide them with experience of one live session, to embed this knowledge.

Ideal for newly appointed Safeguarding Leads, HR Managers, Head of Security, Counsellors etc.

### Group B - Psychological First Aid Trainer Certification

Aim : To provide participants with the skills and knowledge to support students who may have experienced harm or abuse or are struggling with their emotions. Learning how to identify signs and be given a toolkit to use with your students.

Ideal for Wellbeing leaders, Heads of Year / Grade Leaders, less experienced Counsellors

The Train the Trainer courses provide a key group of dedicated professionals who live and work in Cambodia with the skills and tools to train others, in both English and Khmer. This will ensure that the goals of Protecting Children From Harm, will not stop after the Symposium but will expand and spread throughout the region.

### **Child Friendly Interview**

- Five day course / 20-24 people trained to International Law Enforcement Interviewing standards
- Directed at Cambodian National Police (CNP) and Child Protection Officers (CPO), frontline law enforcement and victim advocates
- Expert instruction provided by three international visiting lecturers
- Bespoke training developed for the Cambodian Criminal Justice System, Laws and culture based on international best practice delivered by experts in their field.
