



- Move in fee is \$100 non-refundable, weekly fee is \$125 a week. Weekly fees are due on Sunday at house meeting for the following week. If client arrives in the middle of the week the weekly fee will be prorated \$18 a day.
 - If balance gets to \$500, client will go on Financial Contract and must pay \$150 a week.
 - Must be able to pass a drug test to move in, unless otherwise voted by the house.
 - All new clients are on a Newcomers Contract for the 1st 30 days or until balance is at \$0.
 - While on Newcomer Contract clients are not to have any over nights out, must be home every night by curfew, 11PM weekdays, 12PM weekends and must attend 5 AA mtgs a week. IOP or aftercare count as a meeting.
 - While on Newcomer Contract clients are not allowed to have any guest over (other than sponsor). After off contact client must notify house when having guest over.
 - Clients are responsible for their guest; all guests must follow house rules.
 - Clients must find a sponsor within two weeks of coming to the house and ACTIVELY working the steps throughout their entire stay at Sober Zone. Mrs. Terri will call sponsors and verify.
 - Clients must obtain a homegroup in AA and be of service to that homegroup
 - If client is coming from treatment and has signed up for IOP or aftercare they are required to complete it.
 - It is highly suggested that clients work no more than 40 hours a week until they have completed 12 steps with sponsor.

- Curfew is at 12PM weekdays and 1PM on weekends. All clients must be in the house by curfew. If you are going to be late for curfew, you must let the house manager know.
 - Leaving the house after curfew is not permitted. Unless cleared by the house.
 - Clients can have three overnights away from the house a week but cannot be away more than two consecutive nights a week.
 - If the client is staying away from the houses the house manger must be notified.
 - Client will be Drug/Alcohol tested after being away from the house overnight.

- Clients will be assigned a chore by the Chore Coordinator. Chore days are chosen by the house and chores must be done by curfew. If your chore is not done the chore coordinator will pass out fines \$5.

- Fine money will go to the house and is due at the next house meeting. Failure to complete chores or pay fine money will result in being asked to leave.
 - Rooms must be kept clean, and beds made every morning. No dirty dishes or uneaten food is to be left in the room.
 - Clients must clean their dishes after eating, DO NOT leave dirty dishes in the sink.

- If client is placed on a behavioral or financial contract, clients can not have any nights out until zeroed out or voted off behavioral contract by the house.
 - If client breaks anything in the house it must be replaced in 24 hours. If not replaced the replacement will be balanced to client's account.
 - No women are allowed on Sober Zone properties.
 - No narcotics of ANY KIND are allowed on the Sober Zone properties. The client is responsible for knowing what kind of medications they are prescribed by the Dentist or Doctor's Office. If brought on the property you will be asked to leave immediately.
 - If a client fails a drug or alcohol test you have 15 minutes to collect your things and get off the property.
 - No fighting, tattooing, gambling, or stealing (this includes food).
 - Sober Zone/ Fourth Dimension Properties is not responsible for any damaged or stolen property. Or is responsible for any injuries accrued on the properties, this includes overdoses.
