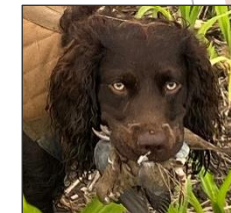

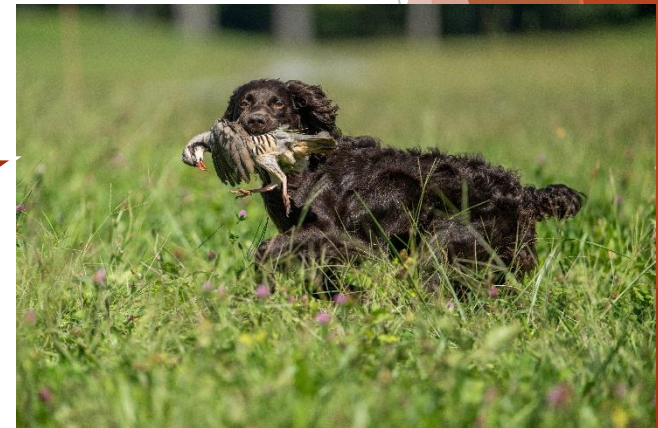

# LEGAL & GOVERNANCE



## Committee Structure

▶The 'Legal and Governance Committee' was formed in 2020. The Compliance Committee, the Constitution and Bylaws Committee, the Standing Rules Committee and Privacy and Confidentiality Committee were assigned as sub-committees. The Charter for the Legal & Governance Committee is in place. The Chair of the Legal & Governance Committee Mike McMahon, reports of one concern with another organization which was dealt with. ▶These Committee Team Leaders also form the membership of the Legal and Governance Committee.

### ▶ Compliance Committee

▶This sub-committee was established to oversee compliance and adherence to the past settlement agreements and to safeguard all legal agreements along with a Board approved legal advisor to assist with any legal questions the Compliance Committee and or Board of Directors may deem necessary and assist the Compliance Committee in discharging its duties. The Committee assesses the BSCBAA compliance practices, nondisclosure agreements, as well as code of conduct and make recommendations to the BSCBAA Board and for other BSCBAA Committees. The Compliance Committee also oversees the adherence of the confidentiality and release agreements of the BSCBAA.

### ▶ Constitution & Bylaws

▶The newest revision of the BSCBAA Constitution and Bylaws was approved August 22, 2022 by membership vote and AKC . It was filed on September 15, 2022, with the State of South Carolina, and the submission has been acknowledged as approved.

### ▶ Standing Rules

▶Continuing to work on establishing Standing Rules for the BSCBAA and all committees. Working with AKC Liaison Committee and past officers.

### ▶ Privacy & Confidentiality

▶Privacy Policy and Terms were developed in 2015 and appears on our website. Confidentiality Agreement was updated in November/December of 2022 and revisions approved January 2023 by the Board. This agreement would safeguard the privacy of any business information pertaining to the BSCBAA for all Board members, Officers, Committee members, and others - during their term of service and after.

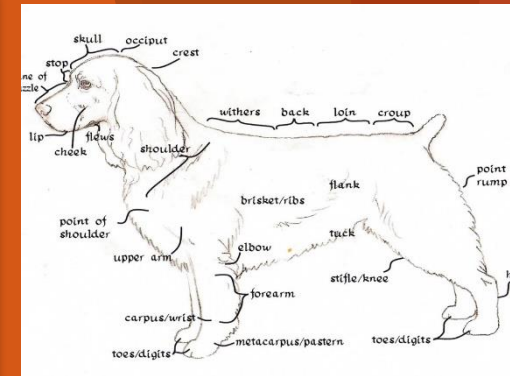

# EDUCATION AND STANDARDS REPORT

- Breed Standard Sub-Committee** - The Boykin Spaniel Breed Standard was Approved by the American Kennel Club and adopted April 2, 2019. Once a standard is approved, there is a five-year moratorium on revisions. A revision consists of any change, deletion, interpretation, or clarification to a standard.
- Mentoring** -- AKC on Mentoring/Ringside Observation - Parent Club approved mentor, an individual with a minimum of 10 years' experience exhibiting or 10 years as an approved judge in that breed. We continue to host Seminars, workshops, several ringside mentoring, electronic tutoring and mentoring and kennel visits. We mentor at the Carolina Foothills in July (3 mentors were available). Katie Eaton has completed the Judges Education Seminar and meets qualifications to be added as a Mentor for the Boykin Spaniel.
- Education** -- Meet the Breed in July at the Houston Show went very well. Several members came with their Boykins. There were many people there to meet our LBDs.
- Judges Education Presentation** - The Judges Education PowerPoint presentation is presented at Judges Education Seminars which is a briefing on the Breed. It has been UPDATED with new pictures and some verbiage. This helps ensure that all presenters are saying the same thing or at least similar and presenting the Boykin as it should be presented. While a living and ever-changing document, the presentation has been standardized with a consistent message. Jackie and Ginger presented to a group of 29 judges at the Judges Symposium in Orlando in conjunctions with the AKC Nationals Friday, December 15th. We received a lot of positive feedback from the Judges about both the revised PowerPoint presentation and the Hands-on portion where we presented a diverse group of 12 Boykins for the judges to go over.
- Boykin Spaniel Judges Breed Study Guide, Illustrated Standard and Breed Standard** will be combined to one document and looking to convert into a handheld for judges to access and carry with them. Presently a work in progress.

# SHOW COMMITTEE

- ❁ We achieved AKC licensed approval for hosting Conformation Events and we hosted our Inaugural National Specialty Show on March 8, 2023 in Kerrville, TX in conjunction with the National Specialty Hunt Test in Hempstead, TX. Both events were very successful, and not only did it fund itself; we exceeded our expectations with a historic record fundraising profit for the BSCBAA.
- ❁ The Show Committee would like to thank all the donators and participants in the auctions/raffles, exhibitors, volunteers, hard workers for both events and the culmination of people from all over the country who helped make it all possible.
- ❁ The National Specialty Guidelines have been created and is meant to be a guide to help future NS committees be successful and should be considered a living document with each new year providing updates.
- ❁ We are also excited about the 2024 National Specialty upcoming in Perry, GA April 14<sup>th</sup>.



# HUNT COMMITTEE

- ❗ The BSCBAA held the Spring 2023 Hunt Tests in Thomson, GA on February 4 & 5, 2023. Report: 1st day there were 29 entries and 13 passes; 2nd day there were 28 entries and 10 passes.
- ❗ We held the National Specialty Hunt Tests on March 4 and 5, 2023 in Hempstead, Texas. 20 of the 25 entries were Boykin Spaniels per day with one scratch on 1<sup>st</sup> day and two scratched on 2nd day. Five passes on first day were awarded and eight passes on second day were awarded. The event with auctions/raffles raised **\$7,803.15** for the club. It was a great time with a lot of successful hunting dogs!
- ❗ The upcoming April NS Hunt Test in GA has been cancelled due to conflict. The Board voted for a Fall HT October 26 & 27, 2024 at LouterCreek Upland Preserve, Tignall, GA. Help is always needed. 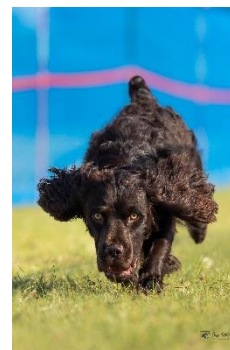
## ▶ AKC Licensing/Liaison (Sue McMahon)
