The Seller guarantees that the Kitten/Cat is a purebred and eligible for registration in the International Cat Association {TICA} or the New Zealand Cat Fancy {NZCF}

The Seller guarantees to have the Kitten/Cat health checked by a registered veterinarian prior to collection and will supply the Purchaser with a copy of this report.

PURCHASER AGREES TO THE FOLLOWNG [Please initial each one]

The Purchaser confirms they are a current full member of a recognized cat club. The Purchaser also confirms they are a current full member of their countries recognised governing council. Breeding rights will only be transferred to registered breeders.

By initialling the below terms the purchaser agrees to abide by them.

All sales are final. No returns, refunds or exchanges except what is outlined by the terms of this sale.

The Kitten shall not be sold, leased or rehomed unless all the conditions of this agreement are met. If the Purchaser chooses to sell the Kitten it must be spay or neutered before leaving the Purchasers possession and property. The Kitten can only be on sold as a pet only. The Purchaser shall email the veterinarian proof of spay/neutering to the Seller. Failure to provide proof of spay/neutering to the Seller will result in the forfeiture of registration papers and the purchaser will pay the seller \$4.00

If for any reason at any time you do not want the Kitten you can return to the Seller free of charge.

THE KITTEN IS SOLD AS A BREEDER. The Seller makes no guarantees for show quality. While we attend the shows with our cats and kittens it is up to the Judge to decide on the quality for showing. We endeavour to breed for wild type and to the TICA & NZCF breed standards.

This cat/kitten is guaranteed to be fertile as adult.

In the unlikely event that this cat/kitten has not produced viable offspring by the age of 18 months, after being bred to at least 2 different studs/queens, with proven fertile cats the Seller will replace the cat/kitten with one of the Purchasers choosing. The said kitten/cat can be returned to the Seller prior to sending a replacement kitten or spay/neutered. Proof of spay/neutering for the registered veterinarian shall be emailed to the Seller. Shipping cost will be shared with the Seller and Purchaser.

Queens are not guaranteed if a proven male does not reside on premises. There is no guarantee against pyometra. The process of breeding is not to be taken lightly, and breeders must take measures to educate themselves on the subject. There are no guarantees against eventual developments of lockets or tail faults. No replacement will be given for any cat that has been bred and produced a litter (purebred or otherwise). If there is a question of whether the cat has been used for breeding, Purchaser agrees to grant Seller full access to veterinarian and TICA records. The Seller does not guarantee the quality of the kittens produced by this Kitten.

Any and all kittens produced by this Kitten are only to be sold as pets they are not to be sold as Breeding Kittens. Only the Purchaser has the right to breed from this Kittens kittens.

The cat/kitten cannot be bred with an unregistered cat or a mixed breed cat unless the Purchaser has the approval of the governing council as part of a breeding program or from the Seller in writing. If such breeding takes place, the Purchaser's will forfeit the Cat to the Seller. Furthermore the kittens will be taken away from the Purchaser. While the Seller acknowledges that accidents happen any half breed kittens shall not be advertise for sale as Bengal or Toyger cross [or variations of] As this cat holds the name of PiperTwinkle the reputation of which is not to be associated with anything other than pure breed Bengals and Toygers.

Breach of this condition will result in legal action with agreed upon damages of \$10,000.00 payable to the Seller.

The Purchaser is responsible for completing and submitting their registration papers

The Seller makes no guarantees as to the Kittens temperament. We pride ourselves on socializing our kittens, but we cannot predict how the Kitten will act after it leaves the familiar environment of our home and its littermates. It is the Purchaser's responsibility to slowly transition the Kitten to its new home. Purchaser acknowledger's that some kittens may take longer than others to adjust to their new surroundings. We encourage the Purchaser to notify the Seller of any concerns within 2 weeks of taking the kitten/cat home. If the Purchaser does not notify the Seller within this time then Seller disclaims any liability of responsibility for these issues.

The Purchaser acknowledges that if they change the Kitten/cats diet this may result in diarrhoea. It is the Purchasers responsibility to ensure the health of the Kitten/cat is looked after once it leaves the Sellers premises. We feed a diet of raw meat such as venison, rabbit and beef with purena dry food with plenty of fresh water available.

The Kitten/cat will have had their first vaccination a flea and a worm treatment before rehoming. It is the Purchaser reasonability to ensure the Kitten/cat continues to have their vaccinations and treatments as prescribed by the Purchaser's veterinarian.

Both parties agree that any disputes/issues related to but not limited to the Kitten's health and to this contractual relationship are a private matter between the Seller and Purchaser. Issues shall not be aired in a public and/or online forum including but not limited to facebook, twitter, Instagram unless prior written consent has be obtained from the other party. Any violation of this clause shall result in an agreed upon damages of \$10,000.00 payable. This sale is final and there are no cash refunds.

HEALTH AGREEMENT

The Seller warrants that the Kitten/cat is sold in good health at the time the Kitten leaves the Sellers premises. Any freight transport that is required to deliver the Kitten is at the Purchaser expense. The Seller advises the Purchaser to take insurance as once the kitten leaves the Sellers premises the Kitten becomes the Purchaser's responsibility.

The Seller warrants that the Kitten has had a physical examination by the Sellers veterinarian prior to the Kitten leaving the Seller [including, but not limited to an eye exam, ear exam, auscultation] and that the Seller is not aware of any health issues [including, but not limited to upper respiratory infections, diarrhoea] at the time the Kitten leaves the Sellers premises. The Seller will supply a copy of the registered veterinarian health certificate to the Purchaser. The Seller encourages the Purchaser to have their own veterinarian examine the Kitten/cat within 72 hrs of arrival. Any medical issues are to be in writing by the examining vet and emailed to the seller. The kitten can not be returned if it has been exposed to another kitten/cat which has not been currently tested for FeLV and FIV. There is no guaranteed against FIP. Return shipping-related expenses are the responsibility of the Purchaser. The Seller agrees to either replace the kitten or refund the purchase price if the kitten/cat develops a hereditary condition within 12months of purchase. The Veterinary expenses incurred by each party shall be there own to bare.

There are no guarantees against FIP in this agreement. It is the Purchasers choice to vaccinate this Kitten against FIP (Feline Infectious Peritonitis). The effectiveness of the vaccine has not been established and the vaccine can cause the disease.

This agreement does not cover the death of the Kitten from FIPV, [feline Infectious Peritonitis virus], a mutated form of the Feline Coronavirus {FCoV}, if this Kitten dies of FIPV it will not be replaced. No Exceptions! We have no control of/over this virus.

This agreement does not cover coccidia outbreaks. When a kitten goes into its new home, this can sometimes result in diarrhea/loose stools a few days after arrival. This is typically caused by the parasite coccidian or a change in diet. This is not a congenital problem. If your Kitten has loose stools, we recommend that you consult your veterinarian.

This Kitten is guaranteed against congenital defects inherited by the parents and HCM for the first 12 months from the purchase date of the Kitten. Should the cat die as a direct result of a congenital defect or HCM, the cat will be replaced ONLY! Seller shall replace as soon as one is available that the Purchaser wishes to choose. The Purchaser must provide the veterinarian or specialist's written report, confirming, in writing, that in their opinion, the cat has a congenital defect.

Multi-cat households: This agreement only covers the health of this Kitten. If the Purchaser has a multi-cat / multi- pet household, or the Kitten is not kept from roaming and your other pets come down with health issues after the Kitten is introduced, the Seller, is not responsible for any veterinary expenses for your other feline(s) and pets, as we are not responsible for their health. Similarly, if the Kitten comes down with health issue(s) after its introduction to the multi-pet household, we will be responsible only if your vet certifies, in writing, that the Kitten's health issues are congenital issues. It is the Purchaser's responsibility to ensure that existing felines are up to date on all vaccinations and have been regularly checked by your veterinarian prior to introducing them to the Kitten. It is the Purchaser's responsibility to quarantine Kitten for at least fourteen (14) days of receiving the Kitten, if the Kitten is going to a multi-pet household. Unless otherwise agreed to by the Seller, in writing, this provision of isolating the Kitten for at least 14 days is a strict requirement and Purchaser will void all health guarantees under this contract if the Kitten is not isolated for at least 14 days.
