"Logbook of World" limited testing is hit

The long-anticipated "Logbook of the World" (LoTW) – the ARRL's secure electronic contact-confirmation system – took a major leap toward public release in late January with several weeks of limited – or "alpha" testing. Dozens of amateur radio operators checked out a preliminary version of the LoTW software, which is still under development. When it's ready, LoTW will provide a means for participants to

qualify for awards such as DXCC or WAS without first having to collect hard-copy QSL cards.

Unlike electronic QSLing systems now in use, LoTW is not set up to exchange QSL "cards" via the Internet. The main idea is that ARRL will maintain a secure log database that will be constantly updated by Dxers, contesters, DXpeditions and thousands of individual amateurs.

Registering and uploading electronic logs will cost nothing. The only time a user will incur a charge is when applying accumulated contact credits toward an award.

New FCC consumer e-mail service now available

The FCC has inaugurated a new e-mail service, The FCC Consumer e-Bulletin, to let consumers know about FCC developments, to disseminate FCC consumer information and to invite comments on FCC regulatory proposals.

Those signing up can expect to receive FCC fact sheets, consumer brochures and alerts, news releases, public notices, notices of proposed rulemaking, reports and orders, and other consumer-related information.

High-speed multimedia hamming

High-speed multimedia hamming via the "Hinternet" could be the next big thing for Amateur Radio. That's the hope of the ARRL High Speed Multimedia (HSMM) Working Group, which is adapting the highly popular IEEE 802.11b Part 15 wireless Internet protocol to Part 97 amateur operating.

"We expect it to be nothing less than revolutionary!" says John Champa, K8OCL, who chairs the ARRL HSMM Working Group--a subset of the League's Technology Task Force. The Working Group's new "High-Speed Digital Networks and Multimedia" page http://www.arrl.org/hsmm/ recently premiered on the ARRL Web site.

Systems employ direct-sequence spread spectrum techniques and operate in the 2.4 GHz range. The term "Hinternet" (ham + Internet), Champa says, is a user-friendly way to refer to the development of high-speed Radio Local Area Networks (RLANs) capable of simultaneously carrying audio, video and data signals.

\$1 million gift funds new scholarship

The ARRL Foundation http://www.arrl.org/arrlf/ has announced the Goldfarb Memorial Scholarship, a full, four-year undergraduate scholarship that will go to a meritorious young Amateur Radio operator about to graduate from high school. The new award is the result of an endowment from the late William Goldfarb, N2ITP.

Each year, to the extent of the funds

available, the Foundation will select a deserving young Amateur Radio operator to receive a "full ride" for his or her undergraduate studies at an accredited baccalaureate degreegranting institution. An on-line application for the Goldfarb Memorial Scholarship is available on the ARRL Web site

ARRL providing license renewal, etc. to nonmembers

The ARRL has announced that it's now providing FCC Amateur Radio license renewals, address changes and other license modification services to nonmembers.

For a \$12 fee, the League will renew a nonmember's Amateur Radio ticket (the license must be within 90 days of expiration), file an application to change address or name or request issuance of a new sequential call sign. For more information contact ARRL VEC, vec@arrl.org.

ARRL announces Amateur Radio CD-ROM presentation

The ARRL soon will make available a new video presentation, Amateur Radio Today, that tells Amateur Radio's public service story to non-hams. Directed by Dave Bell, W6AQ, and narrated by former CBS news anchorman Walter Cronkite, KB2GSD, the presentation runs approximately six minutes. All that's needed to show the presentation to a group is a laptop computer with a CD drive plus a large monitor or a video

projector and screen.


"We wanted to have something for people to take to non-hams and civic clubs," said ARRL President Jim Haynie, W5JBP.

Power line technology shows promise for Internet access

According to an Associated Press report, the FCC's Office of Engineering and Technology has found that power line communications (PLC), which can enable high-speed Internet access over electric power lines, shows promise.

The OET has said that PLC is "beginning to look like a viable alternative to cable and DSL connections to the Internet," AP reported. At present, no regulations prevent the use of electric power lines to provide Internet connections.



The FCC wants to ensure that the technology does not cause

interference problems with other services, however. Some PLC devices use digital signals that occupy spectrum into the upper HF range. These signals can be radiated efficiently by some electrical wiring, so there can be a significant potential impact on Amateur Radio.

AP says two utilities, PPL of Allentown, Pennsylvania, and Ameren of St Louis, Missouri, are working with consumers to test Internet access over power lines. PLC devices use overhead power lines and/or residential electrical wiring to communicate digital signals--for networking within a home or to provide Internet services to entire neighborhoods.

I am spurred on in my thoughts since the ARRL has just released this year's Field Day rules. While I haven't yet pored over them in great detail, there are changes that might be of immediate interest.

The Get On The Air, or GOTA station was introduced to Field Day last year. The GOTA station is to be operated by Novice, Technician or generally inactive hams. This year, a 100-point bonus has been added if the GOTA station can complete at least 100 QSOs during the Field Day period. This is in addition to any QSO points racked up by the GOTA operators.

Here's the Warm Thought Challenge to all of you novices, technicians and generally inactive hams. At least 5 of you step up to the plate, and commit to make at least 20 QSOs each. You can probably do that within a 20 minute period each, but we'll allocate an hour for each. The more of you who operate, the fewer QSOs each has to commit, but twenty is still an admirable, but very reachable goal. How about it? Let me know within the next few months, and I'll arrange for a GOTA station to be there for your use.
