The meeting was called to order at 8:05 by Frank Etzler, President.

Frank introduced Tom Frenaye, K1KI, the ARRL New England Division Director. Tom discussed some of the long term goals and plans of the organization, which will be detailed in *QST* in the coming months.

After a question and answer session with Mr. Frenaye we went on to the club business portion of the meeting.

The Secretary's report was accepted as was the Treasurer's report of \$8,058.

Joe, AB1DO gave a report on the preparations for the Hamfest, including an anti-rain dance.

Ken, KD1DD proposed that the club buy a Decibel Products DB420B antenna for the 440 MHZ repeater system. A CARA club member would be able to obtain the antenna (which sells for \$1,255 wholesale) for \$300. Judy, N1TGK moved and Bob, AC80 2nd the motion. The members of the club in attendance at the October 10, 2008 meeting will be asked to act on this request. The antenna and data sheets will be available at that meeting in order for the members to evaluate the request. Field Day this year included a friendly competition between two operating teams designed to encourage both of our stations to be on the air for the full 24 hours. Field Day was a great success and the "Q Team" was the winner. CARA logo coffee/tea/other cups were presented to the team members. May we emphasize that both operating teams and everyone involved in the Field Day effort contributed to our excellent results this year!

An important item of business was to recognize the many years of service in all club offices (except, as he noted, Vice President) held by John, W1JMA. Club President Frank Etzler presented him with a Certificate of Appreciation. John has taken a new job in Massachusetts and we wish him success in his new position!

CARA Planning Meeting 9-26-2008

Frank, N8WXQ, called the meeting to order at 8 PM. Six club members were in attendance.

Two items of business came up that we would like to present to the membership:

1) Other clubs and organizations have Special Interest Groups (SIG) made up of one or more members having an interest in some aspect of the club's activities. In the case of CARA, the groups could include Contesting, Emergency Operations, HF Operating, DX, VHF/UHF operating etc. The Amateur Radio Club I visit when I go to my sister's in Ohio has 6 members whose special interest is radio controlled aircraft. They fly at a member's farm and also meet for breakfast every Wednesday and talk RC aircraft. The Danbury Area Computer Society has about 12 SIG of various sizes and meeting formats.

2) Over the years CARA has accumulated computer and antenna system

equipment. This material needs to be rounded up and put into controlled storage (perhaps at an EOC location) so when we are asked to help in an emergency or exercise (S.E.T., for example) we can quickly respond.

Also discussed were the following:

Ken, KD1DD went over some maintenance and operational issues for the repeater site. These include problems with the 2M antenna, replacing deteriorated coax cable, moving the 6M antenna to reduce its interference with the 2M signal, replacing the container unit cooling fan and freeing up the container unit door hinges. The continuing problem of there being no access road to the repeater site was also noted.

IARU Booklet Promotes Ethics, Operating Issues

A 67-page booklet, "Ethics and Operating Procedures for the Radio Amateur" by John Devoldere, ON4UN, and Mark Demeuleneere, ON4WW, is available for free download from the ARRL Web site <<u>http://www.arrl.org/awards/dxcc/Eth-operating-ENarrl-SITE-1jul2008.pdf</u>> This is an "Americanized" version of the booklet the authors wrote for an international audience. An international version also is available <<u>http://www.iaru.org/Eth-operating-EN-iaru-SITE-1july2008.pdf</u>>.

At its June 2008 meeting, the IARU Administrative Council endorsed and recommended the principles set out in the booklet as a means of encouraging all radio amateurs "to operate to the highest levels of proficiency, with proper consideration for others using the amateur radio bands" and as a tool "to teach newcomers and others correct operating behavior." The booklet mainly addresses HF operating issues, but the principles are also applicable to VHF and higher bands.

ARRL Chief Executive Officer and IARU Secretary David Sumner, K1ZZ, expressed appreciation for Devoldere's and Demeuleneere's efforts: "The authors are well known, experienced HF operators who are concerned about on-the-air operating standards and who decided that 'It's better to light a candle than curse the darkness.' Anyone who reads their booklet will learn something, no matter how experienced they may be."

CARA Net Script

{ Before starting the net--"Before I call up the weekly Candlewood Amateur Radio Association Net, is there anyone who needs to use this frequency?" -- if no answer, proceed with net. }

"Calling the CARA Net, Calling the CARA Net for [insert Date]

The CARA Net is a directed net. You need not be a member of CARA to join our net as all amateurs are welcome. All traffic will be handled through Net Control. Your Net Control Station this evening is <your call>, my name is <name>, and I am located in <your QTH>. If any station has Emergency or Priority traffic, please call now."

{ if no response, proceed }

"The first part of the net is for check-ins. The second part of the net will be open for questions regarding rigs, computers, or other radio related comments.

At this time we will accept check-ins. To prevent "doubling" please let the repeater drop after you say "this is". Then give your name and callsign.

{ Accept first batch of check-ins...ASK ONE STATION TO ACT AS ALTERNATE NCS!...and acknowledge all who checked-in. }

" <callsign>, Good Evening, <name>. Do you have anything for the net?" {take each station in turn }

{ periodically say , "This is < your call> for the CARA Net are there any additional check-ins, please call now." add additions to the list and acknowledge them. Continue with list. } { On to part 2..} "This is <your call> for the CARA net. The second part of the net is for any new business or amateur radio related questions regarding rigs, antennas, or computers. Are there any questions at this time?"

{ Take & moderate questions/answers. }

{ pre-close } "This is <your call> for the CARA Net. Are there any further topics for discussion, your callsigns please. "

{ Assuming no response...} " Nothing heard. "

{ Close } " This concludes the CARA net for <date>. The CARA Net operates on Sunday evenings at 7:30 pm local time on 147.300, with a PL of 100. All Amateur radio operators are invited to participate.

CARA meets the second Friday of every month at 8 pm at the Stony Hill Firehouse in Bethel, CT. All Amateur radio operators are invited to attend. "
