Special SKYWARN Training Session on Recognition and Reporting of Ice Jams in the Housatonic River on **Monday February 9th from 1830 to 2030 hours local time.**

Location of Training Session **Washington Volunteer Fire Dept 109 Bee Brook Road (Route 47) Washington, Connecticut.**

This is a special training session open to all SKYWARN Spotters, ARES Members, Members of Volunteer Fire Departments, Local Emergency Management Officials, Members of Law Enforcement Agencies, Public Works (Highway) Departments, and Local Government Officials in Litchfield and Fairfield County especially all towns bordering the Housatonic River in Connecticut.

The focus of this training session will be on recognition and reporting of Ice Jams in the Housatonic River. Ice Jams cause localized flooding and can quickly cause serious problems. Rapid rises behind Ice Jams can lead to temporary lakes with flooding of homes and roads along rivers. A sudden release of a jam

can lead to flash flooding below with the addition of large pieces of ice in the wall of water which will damage or destroy most things in its path.

Favored areas for Ice Jam occurrences in the Housatonic River are between Falls Village and the upper end of Bulls Bridge Pond near Kent and especially in several areas of New Milford.

Ham radio fills need after the storm

As phone service faltered last week in Western Kentucky, the state's army of another age emerged.

Ham radio operators ventured to Red Cross shelters and emergency operations centers and drove the roads to connect family members, direct supplies and just keep communications up and running, replacing cell phones and traditional land-line phones.

In Henderson County, a ham radio operator spent four days at the emergency operations center providing supplemental communication for police, fire and emergency medical personnel.

"He was instrumental in helping out," said Kenny Garrett, communications officer and resource coordinator for Henderson Emergency Management.

Sixteen members from the Kentucky Colonels Amateur Radio Club in Western Kentucky brought their equipment and relayed messages around the Bowling Green area, said Henry

Cantrell, better known as call sign W4HTB to members of the group he's known for more than 25 years.

Cantrell said group members set up at a main shelter in Bowling Green and then fanned out to nearby Brownsville and Smiths Grove.

The amateur radio enthusiasts helped shelter occupants find and locate family members at other shelters, some as far west as Paducah.

"They have been very helpful," said Bill Schlicht, emergency services director for the state's South-Central chapter of the American Red Cross.

Schlicht said their efforts "kind of ignited a fire in the spirit of the group," and people are now putting together radio kits to keep in their vehicles for future emergencies.

The group also connected with state Homeland Security officials in Frankfort to relay the number and status of area shelters, Cantrell said.

But the priority, he said, was directing cots, generators and other supplies.

"It was a relief to the county emergency management directors to let them know there was communication help if needed," said Chris Shaw, a local representative of the national group Amateur Radio Emergency Service. Shaw drove around Henderson and nearby counties offering service as communications remained down.

In fact, on Monday, his cell phone was still dropping calls as he was interviewed about his reliable ham radio.

"It looked like a tornado had come through," he said of the devastation he witnessed last week.

Closer to Central Kentucky, ham radio operators were ready to assist as they did in the 2003 ice storm, but found little to do.

"There wasn't much movement out here," said Bill DeVore, secretary for the Bluegrass Amateur Radio Society and a member since 1979.

"But we were ready in case anybody needed us," DeVore said, noting that more than 40 amateur radio operators volunteered around the clock in 2003 to provide communication at area shelters and to assist Kentucky Utilities.

"Hi All,
Terry might be able to go into more detail about exactly what

happened this past weekend with W8ZN/R, but the short of it is the 903-10GHz rotator died about 20 mins into operating from our first stop at Reddish Knob, VA (FM08). 5&10 GHz weren't working, 2&3 GHz rx was way down and 1.2G wasn't transmitting. Turning the truck to point for the uwaves was not going to work for us. Working outside in the 0 deg wx was not an option, so we bagged it and went back to his place after operating for a few hours. I was back to my QTH by 9pm.

Amazingly Terry got everything working by Sunday, including replacing the bad uwave rotator, finding/fixing the bad keying line for 2-10GHz and fixing the 1.2G transverter. We ended up meeting again around 330pm to do a 4 corner grid at FM08/09/18/19. I managed to take some pix from Reddish on Sat. and one of the grids near the four corners, a commercial uwave site we stopped at on Sun eve.

Everything worked fine until the end of the contest. It was great to work those that we could in the short period of time we were on the air. Score to follow later, but obviously not a big one with only about 6-7 hours of operating time.

Lessons learned? Its hard to build a complete rover in a few, cold, winter nights before a contest and expect it to all work the first time out!

ARRL Issues Mobile Amateur Radio Operation Policy Statement



On January 30, at the instruction of the Board of Directors at its January 2009 meeting, the ARRL Executive Committee

adopted a policy statement on mobile Amateur Radio operations. The statement addresses the growing number of proposed state and local laws and ordinances regulating the use of cellular telephone and text messaging, inadvertently affecting Amateur Radio mobile communications.

In its statement, the Executive Committee urges state and municipal legislators to limit the scope of their proposals, limiting them to devices such as full duplex wireless telephones and related hand-held or portable equipment. Alternately, it suggests that licensed Amateur Radio operation be listed specifically as an exclusion to the proposed regulations.

"At the start of each new session, you see a flurry of this type of proposal in state legislatures across the country," said ARRL Regulatory Information Manager Dan Henderson, N1ND.

As of February 1, 2009, Henderson said that the ARRL is aware of proposals in 11 states: Georgia, Hawaii Idaho, Illinois, Iowa, Maine, Montana, Texas, Utah, Virginia and Wyoming, as well as several local city or town proposals.

"These proposals are usually intended to regulate cellular telephone and text messaging by drivers as a matter of safety but, when they are written in very broad terms, can include Amateur Radio mobile operations in the 'net' they cast," Henderson continued. "The Executive Committee's policy statement gives a good, concise background of the role the Amateur Service plays in public safety and service communications. It also highlights the differences between communications conducted by cellular telephone and those using Amateur Radio. Finally, the statement offers some suggested statutory language for state motor vehicle codes which would protect Amateur Radio mobile operation."

The ARRL recognizes that driver inattention is a leading cause of automobile accidents.

The policy statement raises the fact that cell phones utilize full duplex communications -- where the user is talking and listening simultaneously. The Executive Committee statement says "Two-way radio use is dissimilar from full-duplex cellular telephone communications because the operator spends little time actually transmitting; the time spent listening is more similar to, and arguably less distracting than listening to a broadcast radio, CD or MP3 player. There are no distinctions to be made between or among Amateur Radio, public safety land mobile, private land mobile or citizen's radio in terms of driver distraction. All are distinguishable from mobile cellular telephone communications in this respect."

The ARRL Policy Statement also recognizes the responsibility of the amateur community to conduct its activities in a manner that does not create unsafe operation of their motor vehicle. "Safety has to be a top concern at all times," Henderson concluded.

Laura L. Smith to Succeed Hollingsworth



Laura L. Smith of Pennsylvania has been named by the FCC to fill the vacancy created when Riley Hollingsworth, K4ZDH, retired in 2008 as Special Counsel for the Spectrum Enforcement Division of the FCC's Enforcement Bureau. Hollingsworth

served in that position for more than 10 years as the FCC's enforcement watchdog over the Amateur Radio Service <http://www.arrl.org/news/stories/2008/07/03/10198>.

A 1990 graduate of the Pepperdine University School of Law, Smith began her legal career with the FCC, working in the Mass Media Bureau and Wireless Telecommunications Bureau. She also served as Deputy Division Chief of the Public Safety and Private Wireless Division.

In 1998, Smith left the FCC to become Executive Director of Governmental Affairs for the Industrial Telecommunications Association (ITA). In that role, she monitored FCC and legislative proceedings and participated in all regulatory proceedings relevant to the private wireless industry. She was instrumental in the formation of the Consensus Group, a group of public safety and private wireless entities responsible for drafting the "Consensus Plan," a proposed resolution for interference in the 800 MHz band; this was adopted by the FCC in 2004.

Smith has served as an industry consultant and written columns for a variety of trade publications including "Mobile Radio Technology Magazine" and "The Private Wireless Magazine."

In an October 2008 letter to then-FCC Chairman Kevin Martin, ARRL President Joel Harrison, W5ZN, urged Martin to name a successor to Hollingsworth. Calling the FCC's Amateur Radio enforcement program "spectacularly successful," Harrison reminded Martin of the "long period in the late 1980s and 1990s during which the Commission was essentially uninvolved in enforcement in the Amateur Service. The Amateur Service, consisting of some 680,000 licensees of the Commission, is in essence a self-regulating service; however, due to the shared frequency allocations in

the Service and the long distance propagation of amateur communications, a very few rule violators can cause severe disruption in the Service. On the other hand, even a minimal Commission presence has a very strong deterrent value."

Upon learning of Smith's move to the Amateur Radio enforcement role, Harrison remarked that he was "very pleased to see the Commission move forward with the hiring of a new Special Counsel responsible for enforcement of the Amateur Radio Service rules. The Commission acknowledges the self-regulating environment we maintain, but also understands that we need their assistance occasionally to resolve a few situations. They have continually reassured us that this is an important matter for them, and Ms Smith's hiring confirms that."

Copps Named Interim FCC Chairman

On Thursday, January 22, President Barack Obama named current FCC Commissioner Michael Copps as Acting Chairman of the Commission. Copps will serve as Acting Chairman until a new Commissioner/Chairman is confirmed.

ARRL Chief Executive Officer David Sumner, K1ZZ, congratulated Copps on his appointment. "Whenever we have sought a meeting with him or his staff, his door has always been open to us," he said.

Currently serving a second term as FCC Commissioner, Copps began his first term with the Commission in 2001. Before his appointment to the FCC, he served as Assistant Secretary of Commerce for Trade Development at the US Department of Commerce.
