### CARA Meeting Minutes for November 13, 2009

The meeting was called to order by President Frank Etzler, N8WXQ, at 8 PM with 20 members in attendance.

The program for the evening was a discussion of the *ARRL Operating Manual* by Frank, N8WXQ. He used the table of contents as an outline for his talk, selecting topics from each of the chapters. His aim was not to cover the manual in detail but to point out the wide range of information available in this publication and its importance in helping us to properly operate our stations.

A few of the topics he touched on were:

Amateur Radio rules, both formal and informal, including Band Plans. He also mentioned the National Simplex calling frequency of 146.52 MHz.

The Grid Locator Map is very useful, both for giving your location and finding out where the station on the other end is located.

Most of us are familiar with the material covered in the Emergency Communications chapter and Frank emphasized several items, including the ARES Personal Checklist.

As any one who knows Frank will tell you, DXing and Contesting are his babies and he enthusiastically covered those two Chapters and the one on Operating Awards.

Note: "Cute" or "witty" phonetics are ok, Frank said, as long as they don't get in the way of communication. But it is usually best to stay with the standard

phonetic alphabet as published in the References section of the Operating Manual- NITIW.

When it comes to day-to-day station operation this manual is extremely useful and we thank Frank for his presentation.

While on the subject, we are always in the market for monthly meeting programs. In the future I will be doing one on solar power and would be happy to share the stage with anyone else who is working with solar (electric or heating). As many of our past programs have shown, CARA members are doing interesting things and we would like to hear about them. Remember--you are among friends.

The Secretary's report was accepted as was the Treasurer's report of \$10,998.49.

There was a motion to provide up to \$100 to cover some of the costs of the General License up-grade classes. John, W1JMA, made the motion which was seconded by Ken, KD1DD, and it was passed by a voice vote of the members present.

### FCC Looks to Revise, Clarify Vanity Call Sign Rules

On Wednesday, November 25, the FCC issued a Notice of Proposed Rule Making (NPRM) -- WT Docket No. 09-209 -- seeking to amend the Commission's Amateur Radio Service rules to clarify certain rules and codify existing procedures governing the vanity call sign system, as well as revise certain rules applicable to club stations.

According to the FCC, almost 80,000 licensees have replaced their sequentially issued Amateur Radio call signs with a vanity call sign since the program began in 1996. When the program began, the Commission established what they called "the broad outlines" of the vanity call sign system, concluding that call signs generally should not be available for reassignment for two years following the death of a licensee, or expiration or termination of the license for that call sign. In doing so, the Commission made exceptions for former

holders of the call sign, close relatives of a deceased former holder and club stations of which a deceased former holder was a member.

The Commission did not, however, specify all of the procedures governing the vanity call sign system, but indicated that the procedures "would be set out in the Public Notices announcing 'starting gates' for the groups receiving initial priority and that the procedures would be adjusted from gate to gate as experience dictated." The procedures announced in the Public Notices announcing the gates are still in effect, but they are not set forth in the Commission's Rules.

The NPRM states that the FCC "now believe[s] that certain provisions should be codified in our rules, and others added, so that the vanity call sign system will be fair, equitable and transparent to all amateur service licensees. The Commission also decided in the Vanity Report and Order [issued in 1996] to resume issuing new club station licenses. We believe that certain rule changes to the club station licensing rules may be appropriate."
